presently attached with NJP PS under your kind control I, SI Goutam Mallik beg to state that today i.e. on 24.09.21 at 14.15 hrs I received a secret source information that one person namely Sukru Roy of Ghora More, PS- NJP, Dist.-Jalpaiguri is selling ID liquor illegally at his shop at Ghora More, PS- NJP, Dist.-Jalpaiguri for his illegal gain. Accordingly, I diarized the fact in the General diary vide NJP PS GDE No 1250 dated 24.09.21 and informed the fact to you. As per your kind direction and instruction myself along with CV/116 Rohit Kr Mahato CV/306 Biswajit Roy all of NJP PS, SPC left for Ghora More to work out the information in hand. At about 14.45 hrs we arrived at the shop of Sukru Roy of Ghgora More, PS- NJP, Dist.-Jalpaiguri. Being shown and identified by the source I held raid at the shop of Sukru Roy of Ghora More and and managed to apprehended him. During interrogation he disclosed his identity as noted above and also disclosed that he is selling ID liquor at his shop since long for his illegal gain. On search the above noted 1/D liquor recovered from his possession. On demand he failed to produce any documents/licence in respect of store/sale the I/D liquor found at his shop. Accordingly, I seized the above noted I/D liquor from his possession under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search, scizure & arrest was made in between 15.15 hrs to 16.05 hrs on 24.09.21.

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely Sukru Roy (45 yrs) S/O Late Jotin Roy of Ghora More, PS-NJP, Dist.- Jalpaiguri and arrange for its investigation.
