Sir,

In producing herewith two arrested accused persons namely (i) Ranjeet Kumar (27) S/O Janardhan Yadav of Raghapur, PS- Nathnagar, Dist.- Bhagalpur, Bihar ii) Motilal Gowala (37) S/O La Monua Gowala of Khengra, Rabia Sardarpara, PS- Mandai, Dist.- Agartala, Tripura along with the following articles under seizure as per seizure list:

- i. One packet wrapped in Brown Color Cello Tape Containing 10.800 kg said to be Ganja and marked as Exhibit "A".
- ii. One packet wrapped in Brown Color Cello Tape Containing 10.700 kg said to be Ganja and marked as Exhibit "B".
- iii. One packet wrapped in Brown Color Cello Tape Containing 10.700 kg said to be Ganja and marked as Exhibit "C".
- iv. One packet wrapped in Brown Color Cello Tape Containing 10.800 kg said to be Ganja and marked as Exhibit "D".
- v. One white Color Tata Sumo displaying No.- No.JH17A-6261

I, SI Goutam Mallik of New Jalpaiguri PS, Siliguri Police Commissionerate, do hereby lodge this written complaint against above noted accused persons to the effect that on today i.e. 26.09.2021 at 15. 25 hrs I received a secret source information that two persons would be coming from Tripura and proceeds towards Ghoshpukur with huge consignment of Ganja in one vehicle displaying No JH/17/A/6261. Accordingly I informed the matter to SI Samir Tamang, O/C New Jalpaiguri PS, Siliguri Police Commissionerate. and I diarized the fact in General Diary vide New Jalpaiguri PS GDE No 1346 Dated 26.09.2021. Consequently, at 15.25 hrs, myself along with C/453 Kishan Gurung, NVF/0064 Primal Roy both of New Jalpaiguri PS, Siliguri Police Commissionerate left for Gathmabari More, near Mahananda Barrage to verify the veracity of the information vide GDE No 1346 dated 26.09.2021 & vide MCC No.-1863/21 Dated: 26.09.2021 by Govt. Vehicle taking necessary articles like white paper, Arrest Memo, Seizure List, seal, gala wax, candles, match box etc. At about 15.50 hrs we arrived at Gathmabari More, near Mahananda Barrage and parked the vehicle. Meanwhile, I called two independent disinterested witnesses namely i) Nilai Sarkar (34) S/O Ganesh Sarkar of Thakur Nagar Colony, Baribhasa, PS- NJP, Dist.- Jalpaiguri. ii) Nirmal Saha S/o Shyamal Saha of Ambikanagar, PS- NJP, Dist.- Jalpaiguri and I disclosed our identity and informed them about the information in hand and requested them to accompany us in the whole process of search and seizure, if any in which they agreed. Meanwhile, our Police party started looking for accused persons as well as Vehicle and finally at 16.15 hrs we noticed one White Colour Tata Sumo displaying No. JH/17/A/6261 coming from Jalpaiguri Side and proceed towards Ghoshpukur Side. We stop the said vehicle displaying number plate JH/17/A/6261 at Gathmabari More, near Mahananda Berrage driven by the above noted accused person named Ranjeet Kumar (27) S/o Janardhan Yadav of Raghapur, PS- Nathnagar, Dist.- Bhagalpur, Bihar accompanied by the above noted accused person. I directed them to park the vehicle besides the road. I disclosed our identity to them. On being asked they disclosed their name and address as noted above I told them about the information in hand but they denied. Finally after prolonged interrogation they admitted that there is Ganja kept in secret chamber of the vehicle. I, then, gave them option notice in writing that whether they wanted to be searched in presence and supervision of Executive Magistrate or police Gazetted Officer. They agreed to be searched in presence of police Gazetted Officer.
