With due respect and humble submission I Ravi Sharma Son of Sri Mukhlal Sharma of Durganagar, Near Iskon Mandir . Ward No. 40 Under Siliguri Municipal Corporation Post office Sevoke Road, Police Station Bhaktinagar District Jalpaiguri would like to inform you that the abovementioned persons i.e. 1. MD. SADAM Son of Phool Mohammad of Sonapur (employee of Rathi Tyres Sevoke Road), 2. Arjun Chowdhary . 3. Raju Thakur, Son of Rajesh Thakur of Durganagar, Near Iskon Mandir, Siliguri, 4. Suraj Bhagat, 5 Rustam Alam Son of Md Salauddin have together along with other illegal miscreants called my brother Prem Sharma yesterday around from 5 to 6 pm at near Reliance tower ground just adjacent to our house and collectively hit him with sharp weapons and iron pipes(rods) in his head which have resulted in numerous hear fractures and left him thinking he is dead and also took away his one gold chain and one gold ring and damaged his mobile and also took away his purse which contained Rs. 3500/- (Rupees Three Thousand Five Hundred only).

Now the brief fact of the case is that few days ago these boys have eve teased one girl in Salugara Fafri and some known person from Fafri have said my brother to make them understand as my brother used to know them when my brother tried to make them understand this is illegal and can be prosecuted at that time only they have threatened my brother with dire consequences by Md.

Saddam and also threatened that he have good contacts with Bhaktinagar Police so no one can do anything and if he will interfere then he will falsely implicate my brother in theft cases. Looking at this matter when my brother said the person to take action accordingly then yesterday in furious condition they conspired against him by calling him in the reliance tower area to apologies and settle the matter through my brother. Thinking that the abovementioned boys are reformative and trusting them when he went there these abovenamed persons were ready with sharp weapons, iron rods, and other weapons and started abusing him and hitting him. When he tried to escape the other four persons grabbed him in the ground and pressed his neck to suffocate him to death and Md. Saddam hit him with iron rod which was covered with thick cloth with the intention to internal head injury causing him to death but escape bleeding. When my brother was unconscious then the local junior boys took him to Siliguri Civil hospital and informed us.

When we reached there his condition was very serious and his face and head was swollen like anything that we could not even recognize him and at that time he felt little conscious and said their names at that time I could not see his gold chain and gold ring and when I asked he said that they snatched all the things and also damaged the phone so that I cannot contact anyone for help.

Therefore Sir, kindly take strict action against them as the condition of my brother is very serious and grievously injured and looking at his situation we have shifted him to Patna today as our relatives are there and only after today we can know his current status. They are notorious person of our area and if investigation is done properly then our whole local people will say about their anti-social activities. They have attempted to kill my bother by hurting him such grievously and taking away his valuables which is very much scary and illegal in nature that if prompt action is not taken against them then they will emerge as big goons of the area. Hence we have come with our hands folded and clean before you with a great expectation of justice as I am a law abiding citizen and a mechanic by profession in a garage. For us we keep the police authority as the symbol of justice so please it's a request to you from an ordinary public that this faith must be attached between the executive and common man so that the belief in justice system is not evaded by such goons of

the society who thinks that they can do anything to anyone in this society without the fear of law and justice. With great hopes and rightful action I pray you to file a specific case against them and punish them under the preview of law. Thanking You for your kind support and cooperation.
