Subject: F.I.R

In producing herewith one arrested person namely Bapi Saha (28), S/O Dulal Saha of Bhujiapani, Buri Balason, PS - Bagdogra, Dist - Darjeeling along with one vehicle bearing Reg. No. WB 73F 2020 under seizure, I ASI. Mirja Hossain of Matigara P.S do hereby lodge this written complaint to the effect that on 27.09.2021 at 13:55 hrs onwards in course of special Mobile van duty I along with my accompanied force had been to Bansbari Ghat area under Matigara PS and found some persons are about to load riverbed materials on the above noted vehicle bearing No. WB 73F 2020. But, seeing the Police party approaching towards them they started to flee away from the spot. However, after a hot chase we could able to apprehend the above noted person who being asked disclosed his identity as above and further revealed that he is the driver of above noted vehicle bearing No. WB 73F 2020. He further admitted that he under the instructions of the owner of the vehicle bearing No. WB- WB 73F 2020 and others is engaged in mining and transporting of river bed materials from Bansbari Ghat under PS Matigara illegally for their wrongful gain. Accordingly, I seized the above noted vehicle bearing No. WB 73F 2020 under proper seizure list and also arrested him observing all formalities, issuing proper memo of arrest and informing the ground of his arrest.

Under the above circumstances, I pray before you that a specific case may kindly be started against above noted Bapi Saha (28), S/O Dulal Saha of Bhujiapani, Buri Balason, PS - Bagdogra, Dist - Darjeeling and the owner of the vehicle bearing No. WB 73F 2020 and others under proper section of law and arrange for its investigation.
