

My MacBook Pro (13 Inch) (Model No. A1708 ,Serial number- FVFX6RVPHV22, Space grey colour), has been lost yesterday .It was purchased in my name ,S.C. Chaudhury vide Tax Invoice No.879811718500865 dated 03.11.2018 .Through 'find my device', Apple application, the last location was showing near Rongtong Railway Station, Dist - Kurseong at 1648 hrs.(Screenshot of the last location is attached).

The Laptop was in our IOCL Official Car No. WB 52AH 9700(White Scorpio SUV) which was placed in the car at around 1425 hrs at Siliguri Junction in the presence of the car driver and that is the last time we saw it before we boarded the Toy train from Siliguri junction till Rongtong. Shri Anil Thapa is the permanent car driver(Mob No. 7001132587) and even he was informed to take care of the laptop in the presence of my daughter ,my wife and myself.

PDN PS GDE No. 169 We got back in the car again at around 1600 hrs from Sukna Railway Station and we went to Kurseong via Rongtong . We reached Kurseong Tourist Lodge at around 1740 hrs for some tea and snacks. The car was parked in the tourist lodge parking. We started at around 1850 hrs from Kurseong Tourist Lodge towards Siliguri and reached our IOCL Mallaguri residential colony at around 2030 hrs and when we unloaded our things from the trunk of the car after reaching residence, We could not find the laptop. There was another Car No. WB04 1083(White Innova Crysta) who also accompanied us to Kurseong and driver of the car was Akash Roy(Mobile 9614087091).Shri Anil Thapa also called Sh Akash at around 2035 hrs in the presence of my daughter after we reached at our residence.
