Subject:- F.I.R for Accident done by a Toto driver due to overloading on his Toto.

Respected Sir/Madam,

With due respect, I Mukesh Kumar Yadav, S/o - Achchhela Ray, resident of Gudung Basti, would like to state you that today Afternoon around 2 p.m my father who is an L.I.C Agent was travelling in his scooter in Limbu Basti, when a Toto driver overloaded with huge bags weighing around 40-45 kgs, where kept Inside the toto (on the passengers seats) as well as on the roof of the toto and the bags were not even tied with a single rope, and suddenly the bag which was kept on the ceiling/roof of the Toto, fell on my dad's head while crossing each other. Due to which my father received several injuries as well as my Aunt (Anu Singh), who was also travelling with my Dad on his scooter received several injuries as well. My father got a major cut on his lower lips due to which he had to get 2 stitches in his lower lips from Siliguri District Hospital, apart from these my Father's Leg also got injured, due to which currently he is not able to walk on his own. In addition to these, my aunt's leg got fractured, which we got confirmed after doing an X-Ray of my Aunt's left leg in Siliguri District Hospital. With Addition to

all these casualties, my Aunt's Phone worth Rs. 15000, has been damaged. Her Phone's Screen has been fully broken.

In the Afternoon, after these Incident happened, I called up Bhaktinagar Police and handed them the Toto Driver and the Toto, currently he (Toto Driver) is in Bhaktinagar Police Custody.

Lastly, I just want to request you that these type of Incident does not occur with anyone else in the future, for these reason, legal action should be taken on this Toto Driver so that he learns a lesson and does not commit this type of Mistake in the Near Future.
