In producing here with arrested accused persons namely (i) Ranjit Paul (35) S/O Gobinda Paul of Battalion More, and (ii) Md. Mofijul (29) @ Mafidul Md. S/O Md. Mamataz @ Mamatauddin, of Kamrangaguri, both of P.S.- NJP, Dist.- Jalpaiguri with seized articles as noted bellow:

 One Truck (06) wheelers, Tata, having two number plates viz: JH17A/9606 and WB41C/1902 loaded with 465 Bags of Indian Wheat, weight 23.310 M.T.

2. 05(five) copies "CAR PASS", vide S/B NO. 4912954, Dated 28/09/21, issued by Shri Rupen Gurung, Inspector of Customs, Fulbari L.C. Station. Fulbari, India. Dated 04/10/21.

 One Driving Licence No. WB7320170194285, in the name of Mafidul Md. S/O Lt. Mamatauddin of Kamrangaguri, Bhaktinagar, Siliguri, valid upto 02/12/23

In this regard I SI Gautam Laskar of NJP P.S. beg to submit that today 05/10/21 at about 08:30 hrs, on getting information from Duty Officer, NJP P.S. myself alongwith force had been to Naukaghat More, P.S.- NJP, Dist.- Jalpaiguri and found that one Truck bearing Registration No. JH17A/9606, loaded with wheat capsized at Naukaghat More, driver of the said truck namely Md. Mofijul (29) @ Mafidul Md. S/O Md. Mamataz @ Mamatauddin, of Kamrangaguri, P.S.- NJP, Dist.- Jalpaiguri was present there with minor injury. On asking he stated that due to overload he could not control the truck and capsized. He also introduced one person namely Ranjit Paul (35) S/O Gobinda Paul of Battalion More, P.S.-NJP, Dist.-Jalpaiguri as the owner of said Truck No. JH17A/9606. On asking both Driver and owner stated that actually the truck bearing no. JH17 $\Lambda$ /9606 loaded with Indian wheat was supposed to went inside the Bangladesh through Fulbari Indo-Bangladesh border for export but due to non availability of parking place they were trying to park the Truck at somewhere at Siliguri but due to overload it has been capsized. Shri Ranjit Paul handed over me 05(five) copies "CAR PASS", vide S/B NO. 4912954, Dated 28/09/21, issued by Shri Rupen Gurung, Inspector of Customs, Fulbari L.C. Station. Fulbari, India. Dated 04/10/21. On further enquiry they could not satisfy me about the reason why the Truck having "Car Pass" dated 04/10/21 to enter into Bangladesh, proceed towards Siliguri without the prior permission of concerned authority. On doubt I started inspection of said truck and found that the Truck have 02 number plate in both front side as well as back side as WB41C/1902 concealed with another no JH17A/9606 (which was showing in front). On asking both the driver and owner could not give any satisfactory reply in this regard also could not produce any valid document in favour of goods. Driver Md. Mofijul @ Mafidul Md. (29) produced one Driving licence in favour of him. During inspection it could also be found that the Chassis number which is engraved on the Chassis bar has been rubbed to blur the Chassis number and the number is not readable.

Finding no other alternatives I seized the (i) Truck (06) wheelers, Tata, having two number plates viz: JH17A/9606 and WB41C/1902 loaded with 465 Bags of Indian Wheat, weight 23.310 M.T. (ii) 05(five) copies "CAR PASS", vide S/B NO. 4912954, Dated 28/09/21, issued by Shri Rupen Gurung, Inspector of Customs, Fulbari L.C. Station.
