In producing herewith one accused person namely Mahesh Roy (28yrs) S/O Lt. Subodh Chandra Roy of Farabari, Nepali Busty, PO-Sahudangi Hat, PS-NJP Dist- Jalpaiguri along with the following seized articles as per proper seizure list:

- Fourteen (14) Pet Bottles of Galaxy Boss 60 up country spirit (each bottle containing 600 ML)
- Five (05) Bottle of MC. Dowell's Luxury Premium Whisky each bottle containing 180
 ML.
- One (01) Bottle of MC. Dowell's Luxury Premium Whisky each bottle containing 750 ML.
- 4. One (01) Bottles of Kingfisher strong premium Beer containing 650 ML.

I, ASI. Kajal Charaborty of Ambari Falakata out post under NJP PS/SPC lodged a written complainant against the above noted person to the effect that today on 07.010.2021 at 18:05hrs received a source information from Nepali Busty, Farabari, PO-Sahudangi Hat, PS-NJP Dist-Jalpaiguri has gathered huge amount of liquor illegally for selling the same in the customer for his wrongful gain. This refers to Ambari Falakata out post GDE No-217dated 07.10.21. I informed to O/C Ambari Falakata out post about the information. As per his kind instruction I along with, (1)ASI. Rabi Tamang (2) NVF/159 Debranjan Sarkar and CVF/01 Jay Chand Roy proceed to Farabari, Nepali Busty to work out the information. At 18.50 hrs we reached at the spot, sometimes after being identified by the source our police party held raid at Nepali Busty Farabari and recovered the above noted articles from the possession of above noted accused person namely Mahesh Roy (18yrs) S/O Lt. Subodh Chandra Roy of Farabari, Nepali Busty, PO-Sahudangi Hat, PS-NJP Dist- Jalpaiguri. On demand he could not produce any valid license/documents in support of said liquor. He become nervous and admitted his guilt before us and stated that he sell the same in the customer since long for his wrongful gain. In presence of witnesses namely 1) Abhijit Majumder S/o. Lt. Ashim Majumder of Chakiavita, PO. Kamarvita, PS-NJP Dist-Jalpaiguri and 2) Pritam Shekher Das of Ambari Falakata, PO. Kamarvita, PS. NJP, Dist-Jalpaiguri. I seized the above noted articles from the possession of above noted accused person after preparing proper seizure list and took signature of the accused person and witnesses. The seizure was made between 18.55hrs to 19.05 hrs. I arrested the said person u/s 41 Cr.P.C. and issued Memo of arrest appraising the ground of arrest in presence of witnesses.

I therefore request you that a specific case may kindly be started against the accused person namely Mahesh Roy (18yrs) S/O Lt. Subodh Chandra Roy of Farabari, Nepali Busty, Po-Sahudangi Hat, PS-NJP Dist-Jalpaiguri under proper section of law.
