

Sir,

In producing one accused persons namely (1) Sanju Das-26yrs s/o Ajit Das of Purba Majhabari, Gokul More PS Bhaktinagar Dist Jalpaiguri and (2) Ashish Talukdar-30yrs s/o Nantu Talukdar of Jalpai More Sitalapara, PS NJP, Dist Jalpaiguri and seized articles viz: Total Five packets of Winspasmo-Forte capsules composition of Tramadol Hydrochloride-1P 50 mg Acetaminophen 1P 325mg & Dicyclomine Hydrochloride 1P 10mg each packet containing 10 strips and each strips containing 10 Pieces [Total 5X10X10=500 Pieces] contained in a black polethene bag.

I, PSI Sailesh Subba of Bhaktinagar Police Station, Siliguri Police Commissionerate do hereby lodged a written complaint to the effect that on 07.10.21 at 18.05 hrs received reliable source information that two persons were standing at Payel More, near Traffic Point under Bhaktinagar PS with one black polethene bag which contained illegal drugs (Capsules) to deliver the same to someone. It is reasonably believe that the persons possessing the bag containing capsules may escape from the scene if Police party did not reach the spot immediately. The information was reduced in writing vide Bhaktinagar Police Station, GDE no. 381 dated 07.10.21 and informed superiors about the plan and action. Thereafter, myself along with ASI Rabin Lama, C/374 Debraj Biswas, Const/762 Mujibul Rahaman, CVF/935 Bipllab Roy, CVF/014 Labonnomoy Barman and CVF/619 Dharmendra Roy taking blank paper, wax, metal seal and knife and other kits left for Payel More without delay to work out the information vide Bhaktinagar PS GDE No-382 dated 07.10.21

At 18.25 hours I, along with officer and force reached at Payel More and contacted the source who show us the persons with one plastic small bag from a certain distance, suspected to be contained capsules. I, briefed all Officers and force to cordon the persons as tactful as possible in order to thwart their escape from the scene. Meanwhile I, called two independent witnesses namely 1) Sujoy Roy s/o Bhola Roy of South Ektiasal Near Nabajyoti Sangha Ward No-40, PS Bhaktinagar Dist Jalpaiguri and (2) Kamal Thapa s/o Gopal Thapa of Kholachand Fapri, Near Vanubhakta Chowk, PS Bhaktinagar Dist Jalpaiguri after apprising them about the information received and requested them in written to remain present with us during search and seizure if necessary. We, rounded them up and apprehend the said two persons and questioned about their name and address and disclosed their identity as above. On interrogation about the bag possessing by them, initially did not disclose anything about content of plastic sack. I forced them to open it, when they disclosed that the bag contains capsules belongs to them. On further interrogation he disclosed that they procured the illegal capsules from Siliguri side to deliver the same to another person. Then I detained them and gave an option in writing whether they are willing to be searched in presence of an Executive Magistrate or Gazette Police Officer, on return they given written reply that they are willing to be searched in presence of Gazette Police Officer. Then I informed Shri Amaresh Singh, Inspector In-Charge, Bhaktinagar Police Station to come to Payel More requested him to be present during search and seizure of the capsules.

At 19.05 hrs Shri Amaresh Singh, Inspector In-Charge, Bhaktinagar Police Station arrived at spot. Thereafter I, opened the polethene bag and found above seized contraband capsules inside it. I asked the accused persons to produce document if any in support of possessing such a huge quantity of capsules with them but they failed to produce document. I then seized the following articles under proper seizure list in presence of witness under direct supervision of IC Bhaktinagar PS under proper labeling. I informed Drug Controller Jalpaiguri over telephone requesting him to remain present at the spot but he failed to appear the PO.

## NATURE OF ARTICLES SEIZED

1) Five packets of Winspasmo-Forte capsules composition with Tramadol hydrochloride-1P 50 mg Aeetaminophen 1P 325mg & Dicyclomine Hydrochloride 1P 10mg, each packet containing 10 strips and each strips containing 10 Pieces total 5X10X10=500 Pieces packed in a box sealed and Marked as "Exhibit-A" out of which 02 strips of is taken out from Exhibit A as a sample and marked as "Exhibit-A1" contained in brown envelope. (Seizure was made on 07.10.21 in between 19.40 hrs to 21.10hrs)

Under the above circumstances it is evident that the detained persons above named has committed offence under NDPS act. On interrogation the detained accused person confessed their guilt and stated that they are doing such kind of business illegally without any valid documents/License since long for their wrongful gain. It is crystal clear that the accused persons was peddling prescription drugs meant for the sick people to cater to the need of drug abusers in the locality illegally which has become menace to the life of the young generation and perishing the home of thousand parents. I, arrested them u/s 41 Cr.P.C. after explaining them about the ground of arrest issuing proper memo of arrest. Arrested accused persons along with seized articles brought to PS, seizure list and seized articles handed over to Malkhana dealing Officer after intimation to I.C. PS for keeping record in PS property register.

I therefore pray before you that a specific case u/s Narcotic Drugs and Psychotropic Substances Act 1985 may kindly be started against the accused persons namely (1) Sanju Das-26yrs s/o Ajit Das of Purba Majhabari, Gokul More PS Bhaktinagar Dist Jalpaiguri and (2) Ashish Talukdar-30yrs s/o Nantu Talukdar of Jalpai More Sitala para, PS NJP Dist Jalpaiguri and arrange for its investigation.
