Ltd. Siliguri, West Bengal @ Rs 120 each (Amounting of Rs 120/- x 20 =RS.2400/-) in which one sealed bottle has taken from mother packet box as sample as per seizure list.

I, ASI Subir Sen of Siliguri PS, SPC do here by lodged a written complaint against above noted arrested accused person Sandhya Sarkar (60) W/O Late Birnal Sarkar of Tikiapara Vegetable Bazar, New Cinema road, Ward No. 28, PS-Siliguri, Dist- Darjeeling to the effect that on 04.10.21 at 16.15 hrs acting on secret information, I received a source information that the above noted person was busy to sale Id liquor illegally in shop situated at Tikiapara Vegetable Bazar, New Cinema road, Ward No. 28 under Siliguri PS in order to clandestinely dispose the same. Accordingly the fact is diarized in GD vide Siliguri PS GDE no. 231 dated 04.10.21 and informed the fact to I/C Siliguri PS. As per direction of I/C Siliguri PS, I along with ASI Dhruba Mishra, LC/1267 Sasika Rai, LCV/175 Pratima Das, CV-622 Ramanath Barman left for Tikiapara Vegetable Bazar, New Cinema road, Ward No. 28 under Siliguri PS to verify the veracity of the information vide Siliguri PS & D.E. no. 232 dated 04.10.21. On reaching at 16.30 hrs there and as identified by source cordoned the above noted area where she was selling illegal alcohol. On seeing the police party the above noted person tried to escape from the spot but we managed to apprehend the above noted person with the help of lady force and on interrogation, the above noted person disclosed her identity as noted above. On being asked she stated that she used to sale the 60 up Country Spirit to locality without any valid documents as she has violated the norms of Bengal Excise Act for selling the said seized articles without any valid license. As such I. arrested her U/S-41 Cr P.C after observing all sorts' of rules.
