BABLU JAISWAL of Punjab Golden Transport Company arranged one vehicle bearing Registration NO - PB-10FV-6263 having Chassis no - MEC0784CAHP018598 and Engine no - 400922D0007670 , owned by Mr. Kulwinder Singh(Pan no. ASUPS7577G) son of Gurdev Singh having its address at 1431 SEC-32-A, Chandigarh road Ludhiana- 141008 Punjab to carry the said Consignment of Tea bags to the destination.

That the driver of the said vehicle bearing Registraion no - PB-10FV-6263 is Mr. Sandeep Kumar s/o Subash Chand , having its address HO- NO- 740 ST NO 06 Guru Arjun Dev Nagar Samrala chowk Distt. Ludhiana Punjab - 141008. Mr. Sandeep Kumar is holding Indian Union Driving Licence no - PB-1020050051650 . The mobile no. of Sandeep Kumar is 8264747961.

That the said truck was loaded from our godown situated at Baneshwar more Eastern By Pass Siliguri -743004. The truck was loaded with 522 (Five Hundred Twenty Two) bags of teas valued at - 2523614.73/- (Rupees Twenty Five Lakhs Twenty Three Thousand Six Hundred Fourteen and Seventy Three paise only) approx. for carrying /transporting the same to Amritsar Punjab . The truck started its journey on 04/10/2021 and was driven by the above named driver who assured me that the following bags of teas shall be delivered within 09/10/2021.

It is pertinent to mention here that the said vehicle is being maintained by Harjinder Singh & Kaka Dharour s/o Prduman singh having its address Dharaur Ludhiana Punjab - 141120 and the mobile nos. of the above persons are 8146270214 , 8892500001 .

Unfortunately the said truck did not reach the destination with in 09/10/2021. We tried to communicate with the driver by our all means but his mobile was continuously coming switched off .Being no contact with the driver we asked Sri Bablu jaiswal to enquire about the vehicle and the same on 11/10/2021 at 11 pm informed us that the said truck bearing no - PB-10FV-6263 is parked without any consignment load at Garhmukteshwar Brij Ghat Toll plaza Uttar Pardesh -

245205. The information what Sri Bablu Jaiswal shared with us was informed to him by Sri Harjinder singh & Kaka Dharour i.e. the care taker of the said vehicle as per Mr. Jaiswal.

Here we want to state the said vehicle was facilitated with GPS system and with the help of such system the where about of the vehicle can be traced easily. After tracking the GPS system both the care taker Mr. Harjinder singh & Mr. Kaka Dharour left for the spot on 10.10.2021 where the vehicle was to be stood as per the indication of said GPS system. The vehicle was traced out at the same place which was indicated by the system but the said vehicle was found without any Tea bags consignments and in driverless state. All this information was passed to us by Mr. Bablu jaiswal.

That the aforesaid facts clearly reveals that the tea bags loaded in the said truck has been hidden or stolen by the said four persons named Mr. Harjinder singh & Mr. Kaka Dharour (the care takers), Mr. Kulwinder Singh (Owner of vehicle no. PB10FV 6263) and Mr. Sandeep Kumar (the Driver). We are also in a very much doubt that the said Tea consignments may be sold by the said four persons mentioned above or by their associates.

Therefore, I request you to accept this First information Report and do the needful to seize the said truck bearing registration no - PB-10FV-6263 and to recover our 522 (Five Hundred Twenty Two) tea bags from the offenders and punish the culprits as per provisions of law at the earliest and oblige.
