Sub: F.I.R against violation of Injunction Order.

Sir,

- I, Sri Devender Pathak, son of Late Radha Krishna Pathak resident of Sainikpuri, Khaprail (Khopalashi), Post Office New Chumta, Police Station Matigara, District Darjeeling, Pin 734 009 in the state of West Bengal would like to lodge this complaint stating as follows:-
  - 1. That on 05.08.2021 I have filed one Title (Partition) Suit being No. 79/2021 before the Ld. Civil Judge, Senior Division at Siliguri against SRI DHRUB KUMAR PATHAK, son of Late Radha Krishna Pathak resident of Sainikpuri, Manekshaw Marg, Near First Step Nursery School, Khaprail (Khopalashi), Post Office New Chumta, Police Station Matigara, District Darjeeling, Pin 734 009 in the state of West Bengal & Others for partition, declaration separate possession, injunction and consequential reliefs of a plot of land measuring about 11 Kathas along-with a one storied pucca residential building measuring about 1000 Sq. Ft. (approx) and a tin shed structure measuring about 400 Sq. Ft. appertaining to and forming part of Plot No. 345 & 345/452 recorded in Khatian No. 188 & 382 situated at Mouza Khopalashi, J.L.No. 21, Touzi No. 8 within Patharghata Gram Panchayat, Police Station Matigara, District Darjeeling.
  - 2. That after hearing of injunction application the Ld. Court was pleased to pass an order of injunction stating as follows "both the parties of this suit are hereby are hereby directed to maintain status quo in respect of the nature, character and possession of the suit property as on this day till 28.09.2021".
  - 3. That thereafter on the next date i.e., on 28.09.2021 SRI DHRUB KUMAR PATHAK i.e., the Defendant No. 1 after receipt of summons from the Ld. Court appeared in the said Title (Partition) Suit being No. 79/2021 by and through his engaged counsel to contest the case and the said order of injunction was duly extended by the Ld. Court till 15.11.2021.

- 4. That today very surprisingly and shockingly I found that the said SRI DHRUB KUMAR PATHAK i.e., the Defendant No. 1 of the suit by violating the order of the Ld. Court most illegally has started construction upon the roof of the property and has installed tin shed upon the same by erecting pucca pillars, he has also erected pucca pillars upon the vacant land adjacent to the one storied building which was lying vacant at the time of filing of the instant suit.
- 5. That the SRI DHRUB KUMAR PATHAK i.e., the Defendant No. 1 has willfully disregarded the order of the Ld. Court and is looking for an opportunity to grab and/ or enjoy, occupy and possess the same alone by depriving me from my legal right, title and interest upon the same.
- 6. That the order of the injunction passed by the Ld Civil Judge, Senior Division Siliguri is required to be maintained by SRI DHRUB KUMAR PATHAK i.e., the Defendant No. 1 of the suit and without police help it is very much difficult for me to restrain SRI DHRUB KUMAR PATHAK i.e., the Defendant No. 1 from continuing illegal construction works by willfully neglecting and/or violating the order of the Ld. Court.

Your good office is therefore requested to look into the matter seriously and and also please take some appropriate strong legal steps against SRI DHRUB KUMAR PATHAK i.e., the Defendant No. 1 of the aforesaid suit and restrain him from carrying on said illegal construction works so that the order of injunction passed by the Ld. Court in Title (Partition) Suit No. 79/2021 can be maintained properly for the ends of justice.
