Sir.

In producing herewith 02(Two) arrested accused persons namely; (1) Soyel Biswas(20) S/o Ataur Biswas of Sri Rampur, Mallik Para, PS-Kaliya Chawk Dist- Malda 2. Soleman Sk. (19) S/o Hatem Tai of do. with the following seized articles under seizure as per seizure list:

i)One (01) white plastic packet containing 110 grams said to be Brown Sugar recovered from the pant's pocket of (1) Soyel Biswas marked as Exhibit-A from which 10gms extracted as sample marked as Exhibit-A-1.

- ii) One (01) white plastic packet containing 150 grams said to be Brown Sugar recovered from the pant's pocket of Soleman Sk. marked as Exhibit –B from which 10gms extracted as sample marked as Exhibit-B-1.
- I, SI Pratap Basak of Pradhan Nagar PS, Siliguri Police Commissionerate, do hereby lodge this written complaint against above noted two arrested accused persons, to the effect that on today (16.10.2021) at 16:10 hrs I received a specific source information that two persons of Malda standing at Mallaguri near hanuman Mandir with Brown Sugar for disposing the same in locality. The matter has been diarized vide Pradhan Nagar PS GDE No. 931 Dt- 16.10.2021. Accordingly, I informed the matter to you, and expressed the entire information. At 16:20 hrs as per your kind direction myself along with ASI Debasish Das, ASI Ashit Singha, CV/646 Baban Das and CV/645 Pankaj Gupta all of Pradhan Nagar Police Station, Siliguri Police Commissionerate left for Mallaguri Hanuman Mandir to verify the veracity of the information vide M C C. No. 2549/21, Dt. 16.10.2021 which refers to GDE No. 932 Dt16.10.2021 by Govt. Vehicle.

At the time of departure from PS, I took envelope, white paper, sealing wax, gum, seal, Digital weighing machine (Certified by the weight and Metallurgy department) etc. At about 16:35hrs we reached at Mallaguri and parked the vehicle at considerable distance of approx. 100 mtrs and on foot started proceeding towards hanuman mandir and meanwhile called two independent witnesses namely; 1sri Sanjay Paswan(20) S/o Ramdayal Paswan of Rajendra Nagar Cooliepara PS Pradhan Nagar Dist. Darjeeling and 2.Surej Sah (19) S/o Biren Sah of do. and disclosed our identity and informed them about the information in hand and requested them in writing to accompany us in the whole process during search and seizure, if any and they gave in writing about their approval to accompany Police during raid, search and seizure. Being accompanied by source and the witnesses our whole police party started keeping watch over people in and around Mallaguri Near Hanuman mandir and the source identified two persons who were standing near Hanuman mandir. I alerted all my officers and force and proceeded toward them and apprehended them and on being asked they disclosed their identity as noted above.

After disclosing our identity, we detained the above noted two persons with strong reason to believe that they were illegally possessing Brown Sugar in their pocket which was brought for fraudulent disposal for his wrongful gain. On being asked they admitted that they possessed Brown Sugar. I then gave him option whether they wanted to be searched in presence of Executive Magistrate or any Gazetted Officer. They agreed to be searched by one of them. Further, I served them option notice in accordance with provisions of law in this regard in writing and they also gave their approval of being searched by any one in writing in the notice served to him. Accordingly, I informed Sri. Subhashis Chaki, I.C. PS, and requested him to come at Mallaguri near Hanuman Mandir and to remain present and supervise the search and seizure as he being a Gazetted officer. Accordingly, at 16:55 hrs Sri. Subhashis Chaki, I. C. PS arrived at the spot in uniform and disclosed his identity to the detained persons as well as witnesses a Gazetted Officer Sri. Subhashis Chaki, Inspector Incharge, of Pradhan Nagar Police Station. I also offered the independent witnesses and the accused person to search our Police Party as per provision of law. But they refused to search the police party. Under supervision of Sri. Subhashis Chaki, Inspector Incharge, of Pradhan Nagar Police Station, SPC and in presence of two independent and disinterested public witnesses searched the detained persons following all formalities keeping their decency and recovered 110 Gram in white plastic packet said to be brown sugar from pant's pocket of (1) Soyel Biswas and 150 gram said to brown Sugar in a white colour plastic packet

recovered from the pant's pocket of Soleman Sk. On demand in presence of the Gazetted Officer Sri. Subhashis Chaki, I. C. PS they failed to produce any valid document in support of possessing of the Brown Sugar which was kept inside their packet.

I accordingly weighed the Brown Sugar by the weighing instrument and found 260grams of said to be Brown Sugar in two packets and marked as Exhibit- A and Exhibit- B, 10 gms from each packet extracted as sample marked as Exhibit-A-1 & B-1. I labeled and sealed all the article in presence of the Sri. Subhashis Chaki and independent witnesses and accused person. Then, I seized the above noted articles under proper seizure list and label duly signed by the above noted witnesses and the Gazetted Officer Sri. Subhashis Chaki and acknowledged by the accused persons. The seizure was made between 17:15 hrs to18.05 hrs. On further asked the apprehend persons admitted in presence of Gazetted Officer Sri. Subhashis Chaki, I.C.PS and other witnesses that they procured the Brown Sugar from Malda for the purpose of making money. On interrogation they disclosed that they had been dealing in such business of selling the Brown Sugar illegally since long.

Then I arrested the above noted accused persons after observing all guidelines of Apex court of arrest, as they violated the terms and condition of Narcotic Drugs for possessing Brown Sugar without any valid authority & license.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the accused persons namely; (1) Soyel Biswas(20) S/o Ataur Biswas of Sri Rampur, Mallik Para, PS-Kaliya Chawk Dist- Malda 2. Soleman Sk. (19) S/o Hatem Tai of do and arrange for its investigation.
