Sir,

In producing herewith one accused person namely Dhiren Barman (42) s/o Late Jogen Barman of Vivekananda Nagar, Ward No.42, P.O Salugara, PS- Bhaktinagar, Dist- Jalpaiguri along with seized articles viz: 13 (Thirteen) Bottles of Himalayan Gold 60 up Country Spirit (each bottle containing 600 ML.)

I, PSI Sailesh Subba of Bhaktinagar PS under Siliguri Police Commissionerate do here by lodged a written complaint against above noted arrested accused person, to the effect that on 20.10.2021 at 18.05 received a source information that one person namely Dhiren Barman of Vivekananda Nagar, PS- Bhaktinagar, Dist- Jalpaiguri has been selling liquor illegally in his shop to local people for his wrongful gain near Fouji Maath, Vivekananda Nagar under Bhaktinagar P.S. The fact is diarized vide Bhaktinagar PS GDE no 1025 dated: 20.10.2021 and accordingly informed to I/C Bhaktinagar PS and as per his direction I along with ASI Rabin Lama, C/762 Mujibul Rahaman, CV-619 Dharmendra Roy left for Vivekananda Nagar to work out the source information. At 18.25 hrs, we reached on the spot and as identified by the source myself along with force apprehend one person and on being asked, he disclosed his identity as noted above. I, along with force then searched at the shop which was installed on wheelbarrow beside the road and recovered 13 (Thirteen) Bottles of Himalayan Gold 60 up Country Spirit (each bottle containing 600 ML). On demand he could not produce any valid license or documents in support of the said liquor. On interrogation he admitted his guilt and stated that he was selling the same to the local customers since long without any valid license or documents for his wrongful gain. Accordingly I seized the same as per proper seizure list in presence of witnesses and duly sign by the accused person as well as witnesses, the seizure was made in between 18.35 Hrs to 19.05 hrs. Then I arrested him u/s 41 Cr.P.C. and issued the Memo of arrest appraising the ground of arrest in presence of witnesses after observing all sort rules.

Therefore I pray before your kind honour that a specific case may kindly be started against the accused person namely Dhiren Barman (42) s/o Late Jogen Barman of Vivekananda Nagara, Ward No.42, P.O Salugara, PS- Bhaktinagar, Dist- Jalpaiguri under proper section of law.
