Sir,

In producing herewith one accused person named Shibnath Sha @ Biki(20), S/O-Lt. Santosh Sha of Durga Nagar Colony, ward No.04, PO- Siliguri Bazar, PS -Siliguri, Dist - Darjeeling under arrest along with following articles under proper seizure.

1/ 15 (Fifteen) bottles of Himalayan Gold 60 UP Country Spirit [each bottle containing 600 ml, Total 09 (nine) liters] and marked as "exhibit A" ii/ One bottle Himalayan Gold 60 UP Country Spirit taken out from 'exhibit -A' as sample for examination and marked as "exhibit A-1"

I, PSI Shekhar Adhikary of Matigara Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against one accused person named Shibnath Sha @ Biki(20), S/O-Lt. Santosh Sha of Durga Nagar Colony, ward No.04, PO- Siliguri Bazar, PS - Siliguri, Dist - Darjeeling to the effect that today on 22.10.2021 at 20.25hrs received a source information that one person named is selling liquor in a shop situated at Poribahan Nagar under Matigara Police Station without any valid license. Accordingly I informed the matter to the O/C PS and as per his kind direction myself along with C/1035 Santosh Rabidas, C/986 Rajiv Sarkar, CV-155 Sukumar Das had been to Poribahan Nagar under Matigara PS to verify the veracity of source information. On reaching there and as identified by the source found that one person was selling and storing liquor at his shop. Subsequently, I along with my force cordoned the shop and was able to detain the above noted person. Subsequently on being asked the apprehended person disclosed his name and identity as noted above and stated that he is the owner of the shop. Further being searched the above noted seized articles were found in the said shop. On demand he failed to produce any valid license/papers for selling and storing of such articles. On further interrogation he stated that he is involved in selling and possessing of liquor without any valid license for last 06(six) months for his illegal gain. Then I seized and labeled the above mentioned liquor under proper seizure list in presence of independent witnesses and arrested the above mentioned person named Shibnath Sha @ Biki(20), S/O-Lt. Santosh Sha of Durga Nagar Colony, ward No.04, PO- Siliguri Bazar, PS -Siliguri, Dist - Darjeeling after observing all sorts of formalities at the spot. The whole process of seizure and label has been made in between 21:35 hrs to 22.05 hrs at the spot and arrested him after informing the ground of arrest.

I, therefore pray before your good self that a specific case may kindly be initiated against Shibnath Sha @ Biki(20), S/O-Lt. Santosh Sha of Durga Nagar Colony, ward No.04, PO- Siliguri Bazar, PS -Siliguri, Dist - Darjeeling under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
