Sir,

In producing herewith the accused person namely Ashik Biswas (20) s/o Lt. Biswanath Biswas c/o Muni Guring of Shastrinagar, Beside Saigrace School, PS Bhaktinagar, Dist. Jalpaiguri, P/A Kranti Hat, Golabari, PS Malbazar, Dist. Jalpaiguri, along with seized article viz;

1. One sealed packet containing said to be Ganja weighing 5 kgs wrapped with red plastic and cello tape, marked as Exhibit - "A".
2. One sealed envelope said to be Ganja weighing 100 grams taken as sample from Exhibit - "A" and marked as Exhibit - "A-1".
3. One white gunny plastic bag, in which Exhibit "A" & Exhibit "A-1" was kept, Marked as Exhibit "B"

I, SI Prakash Saha of Bhaktinagar Police Station under Siliguri Police Commissionerate do hereby submit this written complainant against the above noted accused persons to the effect that today on 21.10.2021 at 14.15 Hrs I, received specific reliable source information that the above noted accused person has possessed huge amount of Ganja at his Grocery Shop situated at Shastrinagar under Baktinagar PS for peddling the same illegally to adjacent areas of Siliguri. Accordingly I, informed the matter to I/C Bhaktinagar PS in written. The matter was diarized vide Bhaktinagar PS GDE No. 1069, Date, 21.10.2021 and as per his kind direction at about 14.25 Hrs myself along with PSI Sailesh Subba, ASI Deepak Karmakar, ASI rabin Lama, C/374 Debraj Biswas, CV-619 Dharmendra Roy and and CV-014 Labanyamoy Barman of Bhaktinagar P.S left for Shastrinagar by Govt vehicle to verify the veracity of the information accompanied by my reliable source. This refers to Bhaktinagar P.S. GDE No- 1070, Date 21.10.2021. At the time of departure from the office, I took envelope, white paper, sealing wax, gum, seal, official stamp, stamp pad and all necessary requirements. On way to the spot at Shastrinagar, I called two disinterested witnesses namely (1) Suraj Saha s/o Rajkumar Saha of Shastrinagar, PS Bhaktinagar, Dist. Jalpaiguri (2) Ganesh Karmakar s/o Shankar Karmaakar of ITI Road, Shastrinagar, PS Bhaktinagar, Dist. Jalpaiguri and informed them about the information at hand in writing to remain present during search and seizure if necessary, and they gave their approval in writing.

At about 14.50 Hrs. we arrived at Shastrinagar, and as identified and shown by the source cordoned off the Grocery Shop of aforesaid person from all sides to avoid the escape of the suspected person. I, accompanied by my force went inside the said Grocery Shop and apprehended and detained one person. I, disclosed my identity as Police Officer and also my accompanying Police team. On being asked his name and address, he disclosed his name and identity as Ashik Biswas (20) s/o Lt. Biswanath Biswas c/o Mani Gurung of Shastrinagar, Beside Saigrace School, PS Bhaktinagar, Dist. Jalpaiguri, P/A Kranti Hat, Golabari, PS Malbazar, Dist. Jalpaiguri. On further grilling he admitted that he has kept some amount of Ganja at his shop for selling the same to his designed customers for his wrongful gain. His admission arose strong reason to believe that the above noted detained person has illegally possessing the prohibited Ganja at his Grocery Shop. I gave him option notice that whether he wanted to be searched in presence of Executive Magistrate or Gazetted Officer and he agreed in writing that he did not have any objection if the search be made in presence of Gazetted Officer. Then, I requested Sri Amaresh Singh, Inspector -In-Charge, of Bhaktinagar Police Station over Telephone to be present at the P.O. for the purpose of search and seizure informing the whole fact.

At 15.55 Hrs Sri Amaresh Singh, Inspector-In-Charge, of Bhaktinagar Police Station arrived at the P.O. and disclosed his identity to the detained person as Inspector In Charge of Bhaktinagar Police Station under Siliguri Police Commissionerate and that he is a Gazetted Officer. Thereafter, following the formalities of search and seizure in presence Sri Amaresh Singh, Inspector -In-Charge, of Bhaktinagar Police Station the above two witnesses searched the person of each Police personnel of our team and nothing could be found except service fire arms, wearing apparel. Then searched detained person found nothing except wearing apparel. Then, in presence and supervision of Sri Amaresh Singh, Inspector -In-Charge, of Bhaktinagar Police Station and two disinterested witnesses searched the whole shop and recovered 5kg 100 grams of said to be Ganja kept inside one white gunny plastic bag. I, in presence of Gazetted officer and witnesses and Police Party demanded him valid papers / documents of said to be Ganja but he could not produce any documents in respect of the same. Accordingly, in presence and supervision of Gazetted Officer Sri Amaresh Singh, Inspector of Police, Bhaktinagar Police Station and in presence of witnesses, I took 100 grams of said to be Ganja from as sample and packed and sealed labelled both and marked:

1. One sealed packet containing said to be Ganja weighing 5 kgs wrapped with red plastic and cello tape, marked as Exhibit -"A".
2. One sealed envelope said to be Ganja weighing 100 grams taken as sample from Exhibit -"A" and marked as Exhibit -"A-1".
3. One white gunny plastic bag, in which Exhibit "A" & Exhibit "A-1" was kept.

At about 14.50 Hrs. we arrived at Shastri Nagar, and as identified and shown by the source cordoned off the Grocery Shop of aforesaid person from all sides to avoid the escape of the suspected person. I, accompanied by my force went inside the said Grocery Shop and apprehended and detained one person.

I, then, seized the above noted article under proper seizure duly signed by the witnesses and acknowledge by the accused person by putting his signature in seizure list. The seizure was made between 16.35 Hrs to 17.55 Hrs and arrested them U/S 41 Cr.P.C informing him ground of arrest.

On further interrogation, he admitted that he has been doing this business since long for his wrongful gain. He procured above noted seized articles fraudulently and used to sell the same to designed customers at Siliguri area.

Under the above circumstances, the above accused violated the provision of NDPS Act and liable for punishment.

Hence, a specific case may kindly be started against all the accused persons to meet the end of justice.
