

Sir,

In producing herewith one arrested accused person namely Hiralal Sha (71) s/o Late Ram Chandra Sha of Prakash Nagar, Near Sahidnagar More, PS Bhaktinagar, Dist. Jalpaiguri along with following seized articles as per proper seizure list:

- 1. Ten(10) Bottles of 60 UP Himalayan Gold Country Spirit (each bottle containing 600 ml.).
- 2. Seven (07) Bottles of 60 UP Himalayan Gold Country Spirit (each bottle containing 300 ml.).

I, PSI Sailesh Subba of Bhaktinagar PS, SPC would like to lodged a written complaint against the above noted arrested accused person to the effect that on 22.10.2021 at 18.25 Hrs received a source information that one Hiralal Saha of Prakash Nagar has gathered huge amount of liquor illegally in his shop situated at Sahid Nagar More under Bhaktinagar PS for selling the same to the customer for his wrongful gain. Accordingly, I, informed I/C Bhaktinagar PS/SPC about the information over phone and as per his kind instruction, I, along with ASI Deepak Karmakar, CVF/ 619 Dharmendra Roy, CVF/614 Sumit Kumar Roy headed towards Sahidnagar More to work out the information. I along with force reached at Sahidnagar More, and after being identified by the source I along with force entered the aforesaid shop and apprehend one person who disclosed his identity as Hiralal Sha (71) s/o Late Ram Chandra Sha of Prakash Nagar, Near Sahidnagar More, PS Bhaktinagar, Dist. Jalpaiguri and held raid at his shop and recovered the above noted seized articles. On demand he could not produce any valid license/documents in support of said liquor. During interrogation he admitted his guilt before us and stated that he has been selling the same to local people since long for his wrongful gain. I then prepared seizure list of the above noted articles in presence of witnesses namely 1] Khadimul Islam s/o Afaj Uddin of Prakash Nagar, near Sahid Nagar More, Ward No. 43, PS Bhaktinagar, Jalpaiguri 2] Md. Bhushan s/o Lt. Md. Sakur of Sahid nagar, Near Himkali Sahid nagar Sporting Club, Ward No. 43, PS Bhaktinagar, Jalpaiguri undersigned of seizure list. The seizure was made between 19.55 hrs to 20.25 hrs. I arrested the said accused person u/s 41 Cr.P.C. and issued Memo of arrest appraising the ground of arrest in presence of witnesses.

I therefore request you to register a specific case may kindly be started against the accused person namely Hiralal Sha (71) s/o Late Ram Chandra Sha of Prakash Nagar, Near Sahidnagar More, PS Bhaktinagar, Dist. Jalpaiguri under proper section of law.
