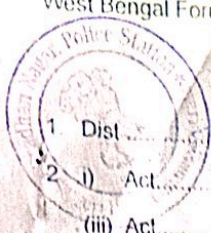

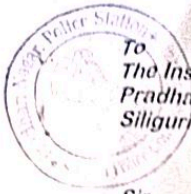

Sir,

In producing herewith one accused persons namely (1) Dhaneshwar Barman (28) S/O Jogesh Barman of Chanmari, P.O. Bairati, Ps. Kotwali/CBR, (2) Mahadev Barman (24) S/O Lalbabu Barman of -DO- under arrest along with following seized articles:-

- (1) 5.300 kgs (Five kg two hundred grams) of said to be ganja inside a black colour soulder bag which was being carried by accused Dhaneshwar Barman marked as exhibit "A".
- (2) 4.200 kgs (four kg two hundred grams) of said to be ganja inside a black colour soulder bag which was being carried by accused Mahadev Barman marked as exhibit "B".
- (3) 100 (50+50 grms) grams said to be ganja extracted from both packets (exhibit A & B) as sample for examination marked as Exhibit - 'C-1'.

I SI- Haren Kumar Mohanta presently posted at Pradhan Nagar PS, SPC would like to lodge this written complaint against the above noted accused person who had been arrested for contravening the norms of NDPS Act to the effect that today on 23.10.21 at 20:15 SI. Rash Behari Saha, ASI. Binod Jha, Const/126 Satrugna Sen, C/166 Gopal Saha all of SOG/SPC came at Ps and informed at Ps that they have a secret information that two persons are moving at Siliguri Tenzing Norgey Bus Terminus carrying huge quantities of ganja in their shoulder bags with a view to sale the same to their designed customer in Siliguri junction area which they procured from Coochbehar also stated that they could be caught red handed, if apprehended immediately. Wasting no time I dialed the information to Pradhan Nagar PS GDE NO- 1303 Dated 22.10.21 and consequently informed the tip off to you for kind instruction. Subsequently on being directed, myself along with SOG team jointly left the PS along with investigating kits i.e. the weighing articles, envelope, gum, seal etc from Pradhan Nagar PS for perusing the information by Govt. Vehicle bearing regd. no. WB 74 AC 9851. under this circumstance any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender. While going to Siliguri Tenzing Norgey Bus Terminus, we stopped and contacted two persons namely (1) Bhola Sahani@Chottu (28) S/O Lt. Jogi Sahani of Ratan Lal Busty, Ps. Pradhan Nagar/Djg, (2) Kishan Ray (24) S/O Bablu Ray of Coolie Para, Ps. Pradhan Nagar, Djg and make them aware of the information in hand and requested them to act as witnesses if any search and seizure would be made necessary upon which they agreed and I gave them notice in this regard. Thereafter we along with the independent witnesses reached at Siliguri Bus Terminus at 20:45 hrs.

On reaching there we contacted with source and subsequently being pointed by source cordoned off two persons at Siliguri Tenzing Norgey Bus stand under PS Pradhan Nagar. Thereafter we disclosed our identity and the information in hand and stated them that they will be searched in person for the purpose. As the odour of ganja was coming out from their shoulder bags of their possession there was enough reason to believe that the article inside the gunny bag were ganja. Subsequently on being asked they disclosed their identity as noted above and thereafter, I gave them the written option to be searched before a Magistrate or a Gazetted Officer upon which they agreed to be searched before a gazetted officer. Consequently I contacted to the I/C Pradhan Nagar PS Sri Subhasish Chaki and stated him about the incident and requested him to be present at the spot as Gazetted officer for supervising the process of search and seizure in presence of witnesses. Sri Subhasish Chaki, I/C PDN PS arrived at the spot at 21:05 hrs and thereafter the process of the search was conducted. Before conducting the search self search of mine and Sri Subhasish Chaki had been conducted by the witnesses. Subsequently on being searched from their two shoulder bag of the above noted both accused persons said to be ganja could be recovered. Thereafter I weighted the recovered ganja from accused persons which stands total 9.500 kgs. Thereafter I seized the recovered Ganja of 9.500 kgs under proper seizure list duly signed by the accused persons and witnesses. The seizure was made in between 21:05hrs to 22:15hrs. In the seizure list I obtained the signature of accused person, Sri Subhasish Chaki I/C Pradhan Nagar PS as gazetted officer, witnesses and put my signature too. The mother packets have been labeled as Exhibit - 'A' & 'B' and took out samples of 100g (50+50)gms from both mother packets and marked as 'C-1' respectively. Consequently the apprehended persons had been arrested issuing Arrest Memo for contravening the norms of NDPS Act and returned back to Pradhan Nagar Ps.

On the above circumstance, I pray before you to start a specific case against the above noted accused person namely (1) Dhaneshwar Barman (28) S/O Jogesh Barman of Chanmari, P.O. Bairati, Ps. Kotwali/CBR, (2) Mahadev Barman (24) S/O Lalbabu Barman of -DO- under proper section of law and arrange for its investigation.
