SUBJECT- LODGING OF FIRST INFORMATION REPORT.

Sir,

With due respect, I, Sri Anirban Chakraborty, Son of Late Asit Chakraborty, aged about 38 years, resident of Anandamayee Colony, Champasari More, Champasari, P.O. and P.S. Pradhan Nagar, Siliguri, District- Darjeeling, Pin- 734003, beg to state as follows-

1. That I got married with one Smt. Gita Sharma, daughter of Sri Yogendra Sharma, resident of Turung Mamring, Upper Mamring, Near Mamring School, East Sikkim- 737132, but presently residing at Sharda Sky-Rise Apartment, Near Pintel Village, Dagapur, P.O. and P.S. Pradhan Nagar, District- Darjeeling, Pin- 734003 on 08.05.2017 at Siddheswari Kalibari, near Indoor Stadium, Deshbandhupara, Siliguri following Hindu Rituals and Customs and started living as spouse at above mentioned address. And before our marriage she was divorcee having one male child name Master Raj Kandoy, was born on 05th October 2005 but she made one fake Adhar Card showing the name of Ronak Kharel date of birth 05/10/2006 and put his father name Romani Kumar Khorel address Turung, Mamring, Upper Mamring, South Sikkim -737132 it is clearly proof that she is the cheating minded. Can play with the future of her own so.

That After some months from our marriage, I noticed that she was headstrong and ill-tempered woman and used to abuse me and my aged mother mentally with filthy languages and also sometimes she physically abused us.

That at that mean time I have already one flat at Sharda Sky-Rise Apartment, 06th Floor, Flat No. 6-B, Near Pintel Village, Dagapur, P.O. and P.S. Pradhan Nagar, District- Darjeeling, Pin- 734003. After almost three months of our marriage she shifted at that flat without my consent along with her child of previous husband and started living there. And no other alternative due to love and affection I used to visit there regularly and started living with her leaving my mother at home alone and bear her all lavish expenses. Every time I requested her to bring my mother to stay with us she always threatened me if I bring my mother she will throw her out from the flat, due to her ill tempered I never dared to bring my mother to stay with me. But there also she tortured me physically and mentally. At that meantime she got pregnant and on 01.02.2018 she gave birth my daughter Miss. Hitisha Chakraborty (Birth Registration No. WB_BR_2018/20122/1/2179, dated 17.02.2018 of S.M.C.). After that the torture upon me increased and she continuously rebuked me with filthy languages and whenever I tried to resist she threaten me she will kill my daughter by giving her poison. She did not allow my mother and family member to enter in my flat to see my newly born daughter.

4. That being a lavish natured woman, she used to stay outside whole day neglecting my newly born baby. That she has a very whimsical life, and further she did not portray

- any sort of love, care and affection towards me. She used to say that I was only a source of money minting for her as she persistently demanded money and expensive luxury items for her use from me to fulfill her materialistic greed and for such purpose she, in various ways mentally, abused and tortured me.
5. That she continuously tortured me and pressurized me to purchase a flat in her name in the same apartment in front of my flat and I purchased the same on 22.12.2020 by availing a loan in my name and we started living there.
 6. That for the sake of my family reputation we decided to file a Divorce on Mutual Consent (257/2019) but she demanded a huge amount from me and give the full custody of my daughter and threaten me if I failed to pay the amount in that case she will indulge me in false cases. Out of that fear I used to pay some amount periodically. But due to Covid Situation, my financial condition became poor and I was not able to pay her.
 7. That in that situation she throw me out from her flat and pressurized me not to return back until and unless I pay all the demanded amount.
 8. That then she lodged a FIR in Siliguri Women PS on 27.07.2021 and a Case (99/2021) started against me and my family members under section 498A, 447, 379, 506 of IPC and we took bail on 16.08.2021. But in that complaint she mentioned that from January 2021 she started living in rented flat in Dagapur but at that time she already became the owner of that flat. In this way she mentioned false statement to Siliguri women PS and fulfilled her ill motive to indulge me in false cases.
 9. After that she again ask huge money from me but I paid 25000/- in her bank account which could not fulfill her greed so again she lodged a complaint in your Police Station Case No. 819/2021 on 07.10.2021 under section 498A, 323 of IPC.
 10. That on other hand she made one false birth certificate of my daughter Miss Hitisha Chakraborty, naming her as Miss Roshni Chakraborty from Champasari Gram Panchayat in 2019 being Registration No. 49 (177/CHMP/12/2019) as well as with the support of that false birth certificate she made one minor Adhaar Card of my daughter naming her as Roshni Chakraborty for her malafied intention. After that with that document she opened one Sukanya Samridhhi Account (A/C No. 73980SSA000000000041) under Central Govt. Scheme in Union Bank of India, Champasari Branch to avail the govt. benefit to fulfill her malafied intention.
 11. That being a cheater minded women, she made two PAN card in her name (CMXPS2810K and IKYPS0929E). She also has Voter Card and Adhar Card issued by Govt. of India as well as she possesses Nepalese Citizenship Certificate in the name of Gita Bhattarai, D/O Yogendra Bhattarai of Taplejung, Nepal. She frequently visited Nepal and started constructing house in Nepal and for that she demanded Rs. 20,00,000/- from me.
 12. That she also cheated Hinduja Leyland Finance Limited and a C.R. Case 436/2015 under Section 406, 420, 421, 506(ii) of IPC is still pending in Ld. J.M. 2nd Court at Siliguri against her.

14. That on 19.03.2021, she took registration of one plot of land of Kalkut Mouza from one Sri Raju Das, son of Sri Manoranjan Das after knowing the fact that the land originally belongs to one Miss Mamta Tamang of Champasari to fulfill her wrongful intention to grab other's land and one Title Suit (97/2021) and one Misc Appeal (11/2021) are still pending against her filed by Miss Mamta Tamang.
15. That as soon as after our marriage due to love and affection I purchased one Parking Space in Bharat Complex, Champasari in her name. To fulfill her lavish demand she tried to sell the parking space to another person but I requested her not to sell or otherwise register the same in my favour and I also paid Rs. 4,50,000/- (which prevail the highest market value) to her and she executed an agreement. But after getting the money she denied to convey the parking in my favour and demanded again Rs. 25,00,000/- which is out of my capacity. Then I send legal notice to her and later on filed C.R. Case (90419/2021) which is still pending.
16. That she also took the key of my flat, two bikes and all belongings in her possession and she denied to give all that things. She do not allow me to enter the house and visit my daughter which created mental agony for me. Whenever I tried to visit the flat to visit my daughter she threatened me to send money otherwise she will lodge false complain against me which is a clear matter of extortion. That the entire events left me mentally shattered. I am suffering from life threatening disease ankolysing spondalities, hypertension, acute anxiety neurosis and insomnia over days. Therefore I have to spent huge amount for my treatment. I need injection on after every 15 days. But all the prescriptions are in her possession. All my necessary documents are under her possession in her flat. Not only mine she has kept original documents of different peoples in her possession. Whenever they asked her to return the original documents she asked them huge amount of money and threatened that she will misuse there documents if they complain anywhere. Even also she kept the original documents of her own sister and her husband and using those documents making many fake documents in Sikkim and taking the benefit of there documents. If I Said her to return there documents she abused me physically.
17. That now a days when my mother stayed alone in home, she used to come and threaten my mother, after no other alternative I shifted my mother to my elder sister's house and I stay in my office.
18. That I am passing my days in extreme fear, agony and mental trauma.
19. That three months before I also made complain to Siliguri Bar Association, Siliguri Police Commissionerate as well as Pradhan Nagar police station copy attached with this but not got any help from anywhere.

In the above circumstances, I humbly request you to take appropriate legal action against abovenamed person according to law and save me from suffering further loss and injury.
