Sub: Complaint against illegal and wrongful construction over the area meant for construction of Community Centre in Uttorayaon Township in violation AND wilful disobedience of the order of injunction as passed in following cases and in violation of the Contempt Rule issued by the Hon'ble High Court, Circuit Bench at Jalpaiguri.

- (1) Order dated: 03.07.2019 and 02.09.2021 passed in Misc. Arbitration Case No. 12 of 2019 by the Court of the Learned District Judge, Darjeeling corresponding to the order dated: 12.09.2021 passed by the Learned Arbitrator Justice Pranab Kumar Chattopadhyay, Former Judge, High Court at Calcutta in Arbitration Proceeding by Sri Jiwan Lal Agarwal, Smt., Rekha Agarwal, Sri Gaurav Agarwal and Smt. Komal Agarwal
- (2) Order dated: 04.06.2019 read with further order dated: 06.01.2021 and 08.02.2021 as passed in CC No. 22 of 2019 read with further order passed in FA No. 617 of 2021 by the Hon'ble National Consumer Disputes Redressal Commission, New Delhi
- (3) Contempt Rule issued by the Hon'ble Circuit Bench of Calcutta High Court,

 Jalpaiguri on 25.02.201 in CRC No. 1 of 2021

With reference to the above, I the undersigned, being the Secretary of Chandmoni Uttorayan Welfare Society, registered under the West Bengal Societies Registration Act, 1961 with its office situates at Uttorayan, PO. Matigara & PS. Matigara -734010, Siliguri, District: Darjeeling [West Bengal] like to inform your good office that the one Sri Jiwan Lal Agarwal, Son of Late Hiralal Agarwal, Smt. Rekha Agarwal, Wife of Sri Jiwan Lal Agarwal, Sri Gaurav Agarwal, Son of Sri Jiwan Lal Agarwal and Smt. Komal Agarwal, Wife of Sri Gaurav Agarwal, all resident of Thirani Mills Copound, Gosala Road, 1" Lane, Post Office Siliguri, District: Darjeeling [West Bengal] have started the construction of their building over the land meant for construction of community centre in Uttorayon Township within the area of Matigara Police Station, in violation and willful disobedience of the orders passed by the following different Courts.

It is stated that recently in a proceedings, which arises in between the above named society and one Luxmi Township & Holding Limited, the Learned Learned Arbitrator Justice Pranab Kumar Chattopadhyay, Former Judge, High Court at Calcutta has been pleased to pass an order on 12.09.2021 in an Arbitration Proceeding to the effect that the interim order passed by the Learned District Judge, Darjeeling on 02nd September, 2021 in Misc. Arbitration Case No. 12 of 2019 will continue till the holding of the next meeting of the parties and that let there be a further interim order restraining both the parties from carrying on any unauthorized construction at the site in question. The copy of the said order dated: 12.09.2021 as passed by the Learned Arbitrator and also the copy of the order dated: 02.09.2021 as passed by the Learned District Judge, Darjeeling is annexed hereto for perusal and consideration of the matter.

It is stated that recently, the Hon'ble National Consumer Disputes Redressal Commission has also been pleased to dispose of an appeal being No. FA/617/2021 which preferred by the above named Sri Jiwan Lal Agarwal and three others, by an order dated: 07.10.2021. The said appeal was preferred by the said Sri Jiwanlal Agarwal & others only against an order dated: 16.09,2021 as passed by the Hon'ble State Consumer Disputes Redressal Commission, Siliguri Circuit Bench. It is clarified here that the said Sri Jiwan Lal Agarwal and three others have challenged the order passed by the Hon'ble State Commission in respect of an application under Section 12(1)(c) of the Consumer Protection Act, 2021 on 16.09.2021 and that they had/have not challenged the injunction order passed by the Hon'ble State Commission, Siliguri on 04.06.2019. And that while deciding the said appeal, the Hon'ble National Commission has not set aside the order of injunction passed on 04.06.2019 in any way rather the Hon'ble National Commission clarified that the order whereby the opposie parties are restrained should remain intact. And such the order of injunction as passed by the Hon'ble State Commission, Siliguri remains intact as there is no other or further order from the Hon'ble National Commission in any way. Contrarily, there is the order of stay passed by the Hon'ble National Commission, New Delhi in FA/499/2021, whereby the Hon'ble State Commission has previously vacated the order of injunction by its order dated: 14.07.20921. And that the order dated: 06.01.2021 and 08.02.2021 as passed by the Hon'ble State Commission, Siliguri are still in force and cannot be violated by any one whosoever. All the relevant orders passed by the Hon'ble State Commission, Siliguri on 04.06.2019, 06.01.2021, 08.02.2021, 14.07.2021, 16.09.2021 and also by the Hon'ble National

Commission, New Delhi on 16.08.2021 and 07.10.2021 are annexed hereto for perusal and consideration of the matter.

Besides the aforesaid proceedings, there is also the contempt rule passed by the Hon'ble Circuit Bench of Calcutta High Court at Jalpaiguri on 25.02.2021 and that the said contempt rule as passed against Sri Jiwan Lal Agarwal and Sri Gaurav Agarwal were/are still in force and in operative. And none of the orders as passed by the different Courts were/are allowing the said Sri Jiwan Lal Agarwal and Sri Gaurav Agarwal to start the construction work over the injuncted area/land meant for construction of community centre.

In view of the above, it is very much clear that the above named Sri Jiwan Lal Agarwal and his associates have started the construction of their building in violation and wilful disobedience of the orders passed by the Learned/Hon'ble Courts and an appropriate action is required to be taken against them as per law.
