Jalpaiguri, do hereby lodge a complaint against my, mother-in-law, Manju Barua, father-in-law, Biswajit Barua, Son of Manoranjan Roy, mother-in-law, Manju Barua, Wife of Biswajit Barua, brother-in-law, Ashok Barua, Son of Biswajit Barua, sister-in-law, Smt. Usha Gupta (Barua) and Smt. Maya Devi Barua, Wife of Ashok Barua, all are resident of Upper Bhanu Nagar, Ward No.43 of SMC, P.O. Sevoke Road, P.S. Bhaktinagar, Dist. Jalpaiguri, to the effects as follows:-

- That my marriage was solemnized on 07-02-2009 along with Shankapriyo Barua as per Hindu rites, rituals and customs.
- (2) That out of the aforesaid wedlock, I gave birth to a male child namely Siddhanth Barua in the year, 2015.
- (3) That as I belong to Nepali Community and husband and in-laws belong to Bengali Community as a result my in-laws frequently abuse me in filthy languages and commit torture upon me mentally naming my community and also abuse and curse me that you have brought no cash, valuable goods, articles, things, furniture, utensils, electronic items etc. from your parental home and use to torture me. They use to demand me and my old aged widow mother to bring cash and valuable ornaments, articles and things from my parental home but my family members could not fulfill their demand and as a consequence they torture me mentally but for the sake of my minor child and for betterment of conjugal life, I tolerated all the above stated cruelty all these days.
- (4) That my in-laws vehemently demanded me and my old aged and ill widow mother to construct a pucca building on the land measuring about 4 Kathas 8 Chhataks belong to my father-in-law acquired by way of inheritance else to

subsequently my widow mother on compound to be subsequently my widow mother on compound to the land total my and my in-laws that 2 Kathas land out of the land total my 4 Kathas 8 Chhataks have to be transferred by my father-in-law by virtue of Gift Deed in my and my husband's favour and accordingly on 05-11-2020, my father-in-law transferred the said land in my and my husband's favour by way of Gift Deed being No.I-1405/2020 and thereafter, my mother out of her money constructed two storied building on our gifted land and one storied building in and over remaining land of my father-in-law but inspite of the same, they have been leave, quit and vacate my residential building else threatening to drove me, my child and my husband from my house.

- (5) That on 14-102021 at about 6:05 pm, my brother-in-law on the instigation and incitement of my father-in-law, mother-in-law and said. Maya Devi Barua, physically assaulted me and my husband and due to his physical assault, I sustained abrasion on my right hand and my husband sustained abrasion on his neck and on his person.
- (6) That my in-laws are still abusing me in filthy languages and committing cruelty upon me taking my community name and threatening me to drive me, my child and my minor child out of my residential home.

So, therefore, I humbly request you take legal action against my inlaws at an earliest.

I shall remain ever grateful for the needful and be obliged thereby.
