Sir,

In producing herewith the following accuseds namely (1) Bishnu Barman (20) S/O Dinesh Barman of Purba Hatiaadanga near Ganga Mandir PS Bhaktinagar Dist. Jalpaiguri (2) Gobinda Barman (20) S/O Rabin Barman of Purba Hatiaadanga Purana Kali Mandir PS Bhaktinagar Dist Jalpaiguri and (3) Nakul Das (21) S/O Baidya Das of Purba Hatiaadanga Near Krishna Paul Math PS Bhaktinagar Dist. Jalpaiguri, in custody along with the following seized articles:-

- i. One (1) Khukri measuring about 11 inches in length made of iron including its wooden butt was recovered from the possession of accused Bishnu Barman (20) S/O Dinesh Barman of Purba Hatiaadanga near Ganga Mandir PS Bhaktinagar Dist. Jalpaiguri.
- ii. One (1) iron made Chopper measuring approx 14 ½ inches length including plastic handle recover from the possession of accused Gobinda Barman (20) S/O Rabin Barman of Purba Hatiaadanga Purana Kali Mandir PS Bhaktinagar Dist Jalpaiguri
- iii. One (1) house breaking implement made of iron with pointed end measuring about 21" in length was recovered from the possession of accused Nakul Das (21) S/O Baidya Das of Purba Hatiaadanga near Krishna Paul Math PS Bhaktinagar Dist. Jalpaiguri.

i. S.I Biswajit Biswas of Ashighar OP P.S Bhaktinager would like to lodge this written complaint against the above noted accused persons and also 10/11 other unidentified persons to the effect that today i.e. on 28.10.2021 at about 21.05 hours received a secret source information that a group of 13-14 persons have assembled at Chota Fapri football ground near forest, under Bhaktinager P.S. Dist-Jalpaiguri with deadly weapons with a view to commit some heinous crime. Accordingly without wasting any time I informed the matter to O/C Ashighar OP and diarised the whole fact in Ashighar OP GDE No. 635 dated 28.10.2021. Then at 21.10 hrs, as per instruction of O/C Ashighar OP I along with ASI Krishna Ch Singh ASI Sumit Baran Nath C/877 Munna Ahmed, CV/1016 Amrit Roy all of Ashighar OP left for spot to verify the veracity of the information and to work upon it, noted in Ashighar OP GDE NO. 636 Dt 28.10.2021. We reached near the spot as directed by the source at about 21.35 hours and stopped at a considerable distance from above noted spot and we started walking towards the P.D with due care so that no one could anticipate our movement. On way we meet two respectable persons of the locality namely (1) Dilip Das (37) S/O Kali Chiran Das of Ghogomali P.S Bhaktinager dist. Jalpaiguri and (2) Ajay Sarkar (31) S/O Sunil Sarkar of Niranjan Nagar w/m 36 PS Bhaktinagar Dist. Jalpaiguri and to whom we disclosed our motto and identity and asked them to accompany us if my search and seizure is necessary for the purpose and they agreed. We reached at the Chota Fapri football ground near forest at about 21.50 hrs and found a group of 13-14 persons sitting at the Chota Fapri football ground near forest. We started approaching towards them slowly ambushing ourselves in the darkness. But unfortunately one of the people among the gang saw us and shouted "Police" at the top of his voice. Thereafter all of them started fleeing away. Anyhow, after a hot chase we could able to apprehend the 03 above referred accused persons. After apprehension the 03 persons disclosed their identity as noted above and also stated that there were 10/11 other persons with them and they were planning to commit a

dacity on the house of a businessman at Baneshwar More area. Thereafter all the apprehended persons were searched in presence of the witnesses and the following articles were seized as follows:-

- i. One (1) Khukri measuring about 11 inches in length made of iron including its wooden butt was recovered from the possession of accused Bishnu Barman (20) S/O Dinesh Barman of Purba Hatiadanga near Ganga Mandir PS Bhaktinagar Dist. Jalpaiguri.
- ii. One (1) iron made Chopper measuring approx 14  $\frac{1}{2}$  inches length including plastic handle recover from the possession of accused Gobinda Barman (20) S/O Rabin Barman of Purna Hatiadanga Purana Kali Mandir PS Bhaktinagar Dist Jalpaiguri
- iii. One (1) house breaking implement made of iron with pointed end measuring about 21" in length was recovered from the possession of accused Nakul Das (21) S/O Baidya Das of Purba Hatiadanga Near Krishna Paul Math PS Bhaktinagar Dist. Jalpaiguri.

Thereafter all the articles were seized in-between 22.05 hrs to 22.25 hrs. Issuing a proper seizure list duly signed by the witnesses and the accused persons. Thereafter all the persons were arrested after observing all formalities of arrest them as they are assembled for committing heinous crime.

On the above circumstances, I pray before you that a specific case may kindly be started against the 03 arrested accused persons namely (1) Bishnu Barman (20) S/O Dinesh Barman of Purba Hatiadanga Near Ganga Mandir PS Bhaktinagar Dist. Jalpaiguri (2) Gobinda Barman (20) S/O Rabin Barman of Purna Hatiadanga Purana Kali Mandir PS Bhaktinagar Dist Jalpaiguri and (3) Nakul Das (21) S/O Baidya Das of Purba Hatiadanga Near Krishna Paul Math PS Bhaktinagar Dist. Jalpaiguri and 10/11 others unidentified persons for such assemble with deadly weapons and accuse for its investigation.
