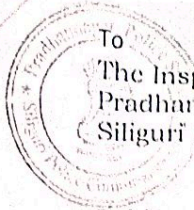

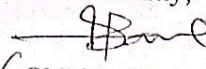

I, SI Dilip Kr. Paul of Pradhan Nagar Police Station under Siliguri Police Commissionerate do here by lodge this written complaint to the effect that today i.e 28.10.2021 in between 23:20 hrs. to 23:35 hrs. Myself along with forces of Pradhan Nagar Police Station had been to Darjeeling more area, PS-Pradhan Nagar, Darjeeling and found the above noted persons were loitering and gathered without wearing mask. On asking the above noted persons stated before me that they were well aware of the pandemic situation and they supposed to wear mask. Hence, they violated the order promulgated by the Govt. of West Bengal for combating the spread of COVID- 19 vide order No 647-ISS/2M-22/2020 dated 15.05.2021 and Notification number 347 -01.S.S / 2M-24/2020 dated 3rd June, 2020 and Memo No 486-CS/2021 dated 24th April , 2021.

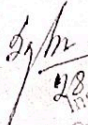
