In this regard I, ASI Debasish Das of Pradhannagar PS. SPC do hereby lodge this written complaint against the above noted accused person to that effect that today on 29.10.2021 at 22.15 hrs received a source information that one person namely Naresh Ch Das of paticolony has storage huge quantity of Fire Crackers at his pan shop at Gate Bazar more, Paticolony "P.S-Pradhannagar,Dist. Darjeeling and shelling the same in open market for his wrongful gain. Without having any license or other document .Accordingly I share the information with you and as per your direction myself along with CV/128 Ajay Sahani, CV/223 Swapan Chhetri ,CV/242 Rakesh Manger left from PS for work out the information vide PDN PS GDE no. 1628 dtd.29.10.2021 and after arrival of Gate bazaar more the source identified the said shop and owner of the shop and I also contact two person namely. 1.Sri Biswajit Roy S/O Lt. Bipul Roy of Ramkrishna Colony ,Ward No. 47 ,2) Sri Prakash Singh S/O Krishna Singh of Champaasari Naya Busty ,ward No. 46 ,both of P.S-Pradhannagar ,Dist,Darjeeling and apprised them about the information in hand and on request they agreed to accompany us the whole raid , search, seizure process.

Accordingly I held raid at the Pan shop styled as "Das Brother" at Gate Bazar more, Paticolony ,P.S-Pradhannagar, Dist. Darjeeling and apprehended the owner of shop noted above and on search his shop recovered the above noted fire crackers and on demand he failed to produce any valid papers or license in support of possessing and selling the huge quantities of fire crackers , On further interrogation, he confessed that he had procured the fire crackers illegally and selling the same in locality for his wrongful gain with violating the Govt. order and which may endanger human life and likely to cause injury of human life . Accordingly, I seized those firecrackers in presence of witnesses and after preparing proper seizure list duly signed by the witness and accused and arrested him after preparing proper Memo of Arrest. The whole process of search, seizure in between 22.45 hrs to 23.25 hrs

I therefore pray before you that a specific case may kindly be initiated against arrested accused Naresh Ch Das (67) S/O Lt. Shib Charan Das of Paticolony Road No.5, P.S-Matigara, Dist. Darjeeling under proper section of law. Enclose:
