I, Smt. Babita Prasad, Wife of Sri.Baleshwar Prasad, Resident of 31/62, Ujanu Shibnagar, Ward No.46 of Siliguri Municipal Corporation, P.O. and P.S. – Matt Salama District - Darjeeling, Pin – 734003, beg to inform you that I have a daughter namely Sikha Prasad aged about 16 years who is a minor. That one Om Sooman Roy @ Bhola @ Shivam Roy, S/o. Sri. Madan Roy, resident of Ujanu Shibnagar, Ward No.46 of Siliguri Municipal Corporation, P.O. and P.S. – Pradhan Nagar, District - Darjeeling, Pin – 734003 is a local resident of our locality and who has a bad reputation in the locality and in the surroundings as because he is always mingles and involved with anti-social activities and anti-social aliments of the locality.

That on 07/08/2021 my daughter was out of the house at about 1,30 pm to bring some groceries from our local shop and when she returned from there she cried to me and told me that said above named Om Sooman Roy @ Bhola @ Shivam Roy stopped her in the middle of the road and tried to touch her inappropriately and when she ran towards the home he also ran behind her but anyhow she entered the house. After knowing that I confronted the said Om Sooman Roy @ Bhola @ Shivam Roy and his family members his father namely Sri. Madan Roy and mother Sangita Roy and requested them to direct their son not to follow or talk to my daughter as she is a minor and at impressionable age but they all abused me with filthy languages and I was compelled to came back home.

That again on 25/08/2021 my daughter told me that said Om Sooman Roy @ Bhola @ Shivam Roy is stalking her repeatedly whenever she is going out of the house for studies and other household work and said Om Sooman Roy @ Bhola @ Shivam Roy tries to contact with her with the intent to interact with her even though she repeatedly shows her disinterest. The said Om Sooman Roy @ Bhola @ Shivam Roy constantly followed and watched her and even tried to contact her directly in the road when she is alone.

That thereafter being the concern mother of a minor daughter I started to accompany her everywhere but I became astonished and shocked that even in my

presence he was still stalked both of us everywhere and when I confronted him on 15/09/2021 at about 11.30 a.m. he abused me and threatened me with dire consequences.

That on 30.10.2021 I was not physically fit and was feeling feverous so I told my daughter to bring some medicines for me from the nearby medical shop and she went out at about 11.30 a.m. to bring the medicine, but she did not returned back to home and then I became worried and I along with my husband started to look for her in and around the locality and also went to the house of my near relatives but we could not find her out. So I along with my husband went to the house of said Om Sooman Roy @ Bhola @ Shivam Roy at about 7.00 p.m. and requested his mother and father to ask them to return my daughter because their son had kidnapped my daughter with ill motive. But they all abused us and threatened us with dire consequences that if we go to the police and register any complain then we will never find our daughter.

That said Om Sooman Roy @ Bhola @ Shivam Roy and his mother and father in connivance with each had kidnapped my daughter and they are abusing and assaulting her sexually and they will sell our minor daughter to do child prostitution if she is not found early.

Sir I am under constant fear for the well being of my daughter life and health and as such I duly request you take proper legal action against said Om Sooman Roy @ Bhola @ Shivam Roy and his father namely Sri. Madan Roy and his mother namely Smt. Sangita Roy and I will be highly obliged to you for your help.
