I, SI Biswajit Ghosh of Detective Department, SPC do hereby producing one arrested accused person namely Arun Ghosh (34) S/O- Swapan Ghosh of C/O- Sanjoy Kar of Hyderpara, Shibrampally, Bibadi Sarani, Ward No-39, PS- Bhaktinagar, Dist-Jalpaiguri (owner of stationery shop styled as Ram Krishna Agency, shop No-D/3 at Nivedita Market, PS-Siliguri, Dist-Darjeeling) along with seized articles viz "Different types of Fire crackers total weighing 130 kgs, market value Rs-1,50,000/- (One Lakh and Fifty Thousand only)" under seizure as per seizure list

In this regard I beg to complain that today i,e on 31 10.21 at 15.35 hrs received a secret source information that one Arun Ghosh shop owner of stationary items styled as Ram Krishna Agency of Nivedita market under PS Siliguri have been storing and selling banned different types of Fire-crackers without having any license or other valid documents violating the provision of law, which may endanger of human life, likely to cause injury and may cause loss of public property of the area. This refers to D.D,SPC GDE No. 149 dated 31.10.21. Accordingly, I informed the matter to ACP,DD,SPC. As per order, I accompanied with SI Swadesh Saha, ASI Proloy Bhattacharjee,ASI Abu Taleb, Const-371 Sushanta Dey, Const-813 Gyanendra Ch Sarkar rushed to the spot to work out the information vide D.D,SPC GDE No. 150 dated 31.10.21. On reaching at Nibedita Market I contacted with source and as shown by source cordoned the Stationary shop.

Then I conducted raid in the said stationary shop of Arun Ghosh. On being searched I recovered the different types of Fire crackers total weighing 130 kgs market values 1,50,000/- (One Lakh and Fifty Thousand only) from the said stationary shop. On being asked regarding storing and selling Fire Crackers, he could not produce any documents/licenses in support of the possession of such quantity of Fire Crackers. It is pertinent to mention here that the shop of above noted accused namely Arun Ghosh is situated in the densely market area of Nivedita Market nearby Siliguri District Hospital and it's adjacent areas are also densely populated area, the accused was storing such illegal business of banned fire crackers without any safety measure and without any permission from appropriate authorities, and also violated the order of Hon'ble High Court Calcutta. If any accident took place due to negligent act of the accused person that may cause loss of life and property of the area. The Fire crackers were stored without any precautionary and safety measure. Accordingly, I seized the fire crackers in presence of witnesses namely i) Sanjoy Kar s/o-Tarun Kar of Hyderpara, Shibrampally,Bibadi Sarani, Ward no-39, P.S-Bhaktinagar Dist-Jalpaiguri ii)Jogesh Mohanta s/o-Jagadish Mohanta of Thiknikata, PO-Sushruta Nagar PS-Matigara Dist-Darjeeling duly signed by the witnesses and accused person in between 15.45 hrs and 16.15 hrs. Then I arrested the above noted accused person U/S 41 Cr.P.C.

Under the above circumstances, I pray before your kind honour that a specific case may kindly be started against the above noted arrested accused person namely Arun Ghosh (34) S/O- Swapan Ghosh of C/O-Sanjoy Kar of Hyderpara, Shibrampally, Bibadi Sarani, Ward no-39, P.S- Bhaktinagar Dist-Jalpaiguri and arrange for its investigation.
