Respected Sir, With deep grievances, I beg to inform you that few persons have put ghumbis, stalls, movable four wheeler shops with Kachha shades in my vacant plot M-92 just enfront of gate of WEDEL IT PARK OFFICE COMPLEX at parishram Nagar, Matigara, Dist: Darjeeling (W.B). These are residents of Ghokrajat of patharghatta grampanchayat of Matigara.

As informed by local persons, these are Mr. Susat Barman, Mr. Narayan alias Ship, Mr. Bishesh Roy, Mr. Jiten Roy, Mr. Poudip Sorkar ^{Gram panchayat} some more whose name I don't know. These are residents of Ghokrajat of patharghatta.

I have complained on line and by email Ojra Bask and again Ojra Bask and 2 months back, office of the Commissioner, Siliguri metopo. Mahara police and copy to Matigara & High officials by email & Whatsapp. Mahara police acted 1-2 time and removed them but no legal action was taken against them, these are habitual offenders and repeatedly put stalls, shops, ghumbis and do their business there regularly.

Therefore, I request you to take actions, so that same offenders don't repeat crime by encroaching my land. I have put 2-3 times Kachha Barricade and walls too but they also break it and come inside my land. A video has been whatapped to the police Commissioner too.
