I, Sri Suren Chhetri, Son of Late Bal Bahadur Chhetri, resident of Kholachand Fafri, P.O.- Salugara, Police Station - Bhaktinagar, District - Jalpaiguri, do hereby lodge a complaint against Shyamal Chandra Biswas, Son of Jiwan Biswas, Subhoranjan Biswas Son of Ratan Biswas, Pankaj Barai Son of Gurudas Barai, Pijush Barai Son of Guru Das Barai, Subho Bhakta Son of Sunil Bhaktal and Prasanjeet Roy Son of Bablu Roy all are resident of Kholachand Fafri, P.O.- Salugara, Police Station - Bhaktinagar, District - Jalpaiguri, to the effect that on 31-10-2021 at about 7:30 pm, at Seventy More, near Forest Renger Office, the abovenamed persons physically assaulted my son namely Suraj Chettri, with Sharp Weapons like Iron rod, Battam, fists, blows, Bamboo stick, kicks and stones and due which my son sustained grievous head injuries with bleeding and injuries on other parts of his body with intention to kill my son in front my son's friend and due to which he is senseless. My son's friends rescued him from the further physical assault and if he would not been rescued in time they would have killed my son. Due to causing of grevious hurt with an intention to kill my son, he sustained severe bleeding head injury.

That immediately he was taken at Siliguri District Hospital, Siliguri, Dist. Darjeeling and thereafter referred him to North Bengal Medical College and Hospital, presently he is admitted in the said hospital fighting for his life and death the concerned Doctor has advice me to have CT Scan of his head immediately.

So, therefore, I humbly request to inquire into the said matter and may take necessary legal steps against the said persons at an earliest.
