Sir,

In producing herewith one arrested accused person namely TAPAN ROY-19YRS S/O SUBHODHAN ROY OF AMTALA, BOTTLE COMPANY, WARD NO-41 PS BHAKTINAGAR DIST JALPAIGURI along with the following seized articles as per proper seizure list:-

1. 20 (twenty) no's of pet Bottles of Himalayan Gold 60up country sprit (each bottle containing 600 ML)
2. One red & Black colour Hero Glamour motor cycle bearing No-WB74AY/3787

I beg to report that I, ASI Dipak Karmakar of Bhaktinagar PS under Siliguri Police Commissionerate lodged a written complainant against one TAPAN ROY-19YRS S/O SUBHODHAN ROY OF AMTALA, BOTTLE COMPANY, WARD NO-41 PS BHAKTINAGAR DIST JALPAIGURI and Smt Sumoti Roy w/o Kathin Roy of Do to the effect that on 01.11.21 at 22.20 hrs received a source information from Amtala bottle company more near Kalibari, under Bhaktinagar PS that one lady namely Smt Sumoti Roy has gathered huge quantity of liquor in her street shop at Amtala bottle company more near Kalibari under Bhaktinagar PS for selling the same in the open market for her wrongful gain without any documents/license. Diarized the fact in GD vide Bhaktinagar PS GDE No- 58 dated 01.11.21. As per your kind instruction myself along with force proceeded to the PO to work out the information. At 22.35 hrs we reached at the spot, sometimes after, being identified by the source our police party held raid and recovered the above noted articles from the possession of one Tapan Roy which was kept in a nylon bag and hanged with the motor cycle bearing No-WB74AY/3787. During local enquiry it came to learn that Smt Sumoti Roy selling the same in open market since long for her wrongful gain without any valid documents/license. During raid Sumoti Roy manage to flee away from the spot. In presence of witnesses I seized the above noted articles from the possession of Tapan Roy after prepared proper seizure list and arrested him after maintain all formalities. Arrested person admitted that he sell the seized articles to the general public on behalf of Sumoti Roy w/o Kathin Roy of Amtala, Bottle Company more, near Kalibari PS Bhaktinagar Dist Jalpaiguri (The seizure was made in between 22.40hrs to 23.10hrs)

I therefore request you a specific case may kindly be started against the accused persons namely TAPAN ROY-19YRS S/O SUBHODHAN ROY OF AMTALA, BOTTLE COMPANY, WARD NO-41 PS BHAKTINAGAR DIST JALPAIGURI and one another SMT SUMOTI ROY W/O KATHIN ROY OF AMTALA, BOTTLE COMPANY MORE, NEAR KALIBARI, PS BHAKTINAGAR DIST JALPAIGURI under proper section of law and arrange for investigation..
