In producing herewith two (02) arrested accused persons namely 1 Md. Alam (48) @ Dilip, S/O-Lt. Md. Idrish, and 2. Md. Abu Kalam (19), S/O- Md. Alam (48) @ Dilip both of Biswas Colony Rail Gate, PO+PS-Matigar, Dist. Darjeeling along with the following articles under proper seizure as per seizure list;

a) One Red colour Pittu bag styled as 'adldas' containing 30 (thirty) bottles of "Lykarex" Cough Syrup (each bottle containing 100 ml) having Batch No. TBHU 0272, Mfg. Date: 02/2021. Exp. Date: 01/2023 which was seized from exclusive and conscious possession of above noted Md. Alam (48) @ Dilip and marked as "Exhibit-A".

b) One (01) bottle of "Lykarex" Cough Syrup (containing 100 ml) randomly taken from "Exhibit- A" for examination and marked as "Exhibit A-1".

c) One Grey-black colour Pittu bag styled as 'adldas' containing 24 (twenty-four) bottles of "Lykarex" Cough Syrup (each bottle containing 100 ml) having Batch No. TBHU 0272, Mfg. Date: 02/2021. Exp. Date: 01/2023 which was - seized from exclusive and conscious possession of above noted Md Abu Kalam and marked as "Exhibit-B".

d) One (01) bottle of "Lykarex" Cough Syrup (containing 100 ml) randomly taken from "Exhibit-B" for examination and marked as "Exhibit B-1".

e) Cash Rs. 19780/-(Nineteen Thousand Seven Hundred and Eighty rupees only) in Indian Currency note in following denomination:-

I, PSI Abhishek Theengh, S/O- Suchandra Kumar Theengh of Matigara Police Station, Siliguri Police Commissionerate do hereby lodged this written complaint against the above noted accused persons namely 1 Md. Alam (48) @ Dilip, S/O-Lt. Md. Idrish, and 2. Md. Abu Kalam (19), S/O- Md. Alam (48) @ Dilip both of Biswas Colony Rail Gate, PO+PS- Matigar, Dist.- Darjeeling to the effect that on 02.11.2021 at about 14:35 hrs I received a specific source input that two persons possessing huge quantity of 'Codeine Phosphate' based drugs were standing at Matigara Biswas Colony More under Matigara PS to sell the same to their designed customers. The matter was diarized in Matigara PS GDE No. 81, Dt. 02.11.2021 and subsequently, I informed the matter to the Officer-in-Charge, Matigara Police Station in written and being directed, myself along with SI Rash Bihari Saha, ASI Binod Jha, C/166 Gopal Saha all of SOG team, SPC and PSI Newton Biswas, C/1035 Santosh Robidas all of Matigara PS, SPC along with investigation kit left for Matigara Biswas Colony More under Matigara PS by Govt. vehicle to verify the veracity of the information. This refers to Matigara PS GDE No. 82, Dt. 02.11.2021 and M.C.C No- 637/2021 Date- 02.11.2021.

Under this circumstance any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender.

On way to Matigara Biswas Colony More under Matigara PS I contacted two persons namely (1) Reeju Khan(39), S/O-Lt. Riyaj Khan and (2) Parimal Sarkar(40), S/O-Lt. Brojen Sakar both of Tumbajote, Beldangi, P.O+PS- Matigara, Dist- Darjeeling and make them aware of the information in hand and requested them to act as witness, if any search and seizure would be made necessary upon which, they agreed. Thereafter, we along with above noted independent witnesses arrived at Matigara Biswas Colony More under PS- Matigara at 15.25 hrs and subsequently, being pointed by my source, detained 02(two) persons standing at Matigara Biswas Colony More under Matigara P.S and each of them carrying pittu bag under their exclusive and conscious possession. Thereafter, we disclosed our identity and the information in hand stated them that they as well as the bag under their possession will be searched for the purpose. And, I also gave them option in writing to be searched in presence of an Executive Magistrate or by any Gazetted Officer upon which they agreed to be searched in presence of any one of the above. I also offered the independent witnesses and the accused persons to search our Police Party as per provisions but, they did not search the police party. Consequently, I informed the matter to O/C Matigara PS and as per his kind order, I informed to Shri Santanu Tarafder, Assistant Commissioner of Police(AP), Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate of SPC for the day, regarding the interception of the accused persons suspected to be possessed 'Codeine Phosphate' based drugs illegally and requested him to come at Matigara Biswas Colony More under Matigara PS to remain present and to supervise the search and seizure. Date: 01/2023 containing total containing 100 ml) having Batch No. TBHU 0272, Mfg. Date: 02/2021. Exp. Date: 01/2023 containing total X 100 ml = 3000 ml i.e., equivalent to 3.0 Kg].

It has been found from the bag under the exclusive and conscious possession of the above noted accus person namely Md. Abu Kalam (19) containing 24 (twenty-four) bottles of "Lykarex" Cough Syrup (each bot containing 100 ml) containing total 24 X 100 ml = 2400 ml i.e., equivalent to 2.4 Kg].

Further, on demand in presence of Shri Santanu Tarafder, Assistant Commissioner of Police (AP), Silig Police Commissionerate detailed for acting as Special Executive Magistrate of SPC the detained persons named and all the special executive Magistrate of SPC the detained persons named and all the special experiences of explanation. Md. Alam (48) @ Dilip & Md. Abu Kalam failed to produce any valid documents/papers or explanation possessing of such huge quantity of 'Codeine Phosphate' based drugs beyond the prescribed limit.

Abu Kalam at the spot at Matigara Biswas Colony More under PS- Matigara, Dist- Darjeeling und proper seizure list in presence of independent witnesses and Shri Santanu Tarafder, Assistant Commissioner Police(AP), Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate, SPC obtains their signature and being acknowledged by the accused persons namely Md. Alam (48) @ Dilip & Md. A

Subsequently, I labelled and sealed the seized articles at the spot at Matigara Biswas Colony More und PS- Matigara, Dist- Darjeeling in presence of Shri Santanu Tarafder, Assistant Commissioner of Police(A Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate, SPC and independent witnesses and the accused persons namely Md. Alam (48) @ Dilip & Md. Abu Kalam. The whole process seizure was made in between 16.45hrs to 17.35hrs.

Being further interrogated, the apprehend persons namely Md. Alam (48) @ Dilip & Md. Abu Kal admitted in presence of Shri Santanu Tarafder, Assistant Commissioner of Police (AP), Siliguri Pol Commissionerate detailed for acting as Special Executive Magistrate of SPC and independent witnesses to they have procured the 'Codeine Phosphate' based drugs clandestinely for the purpose of selling the same high rate to their designed customer for their personal gain by illegal means. They also disclosed that they have been dealing in this business of procuring and selling of 'Codeine Phosphate' based drugs illegally for last months for their wrongful gain.

From the above noted facts and seizure of incriminating articles it is quite evident that the accused perso namely Md. Alam (48) @ Dilip & Md. Abu Kalam are involved in procuring and selling 'Codeine Phospha based drugs illegally contravening the norms of NDPS Act.

Then, I arrested the above noted accused persons namely Md. Alam (48) @ Dilip & Md. Abu Kalam al observing all formalities and informing the ground of their arrest and issued necessary Memo of Arrest.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly started against the accused persons namely 1.Md. Alam (48) @ Dilip, S/O-Lt. Md. Idrish, and 2. Md. Abu Kal (19), S/O- Md. Alam (48) @ Dilip both of Biswas Colony Rail Gate, PO+PS- Matigar, Dist.- Darjeeling a arrange for its investigation.
