Enterprises.(each packet containing 10 pieces),

3) 39 (THIRTY NINE) Packets of GOLDEN KING COBRA (EXTRA POWER) ELECTRIC POWER, by Thamaraikannan Fireworks Sivakasi (each packet containing 28 pieces),

4) 10 (TEN) Packets of RHINO POWER CHOCOLATE BOMB by SS Enterprise

Kolkota.(each packet containing 10 pieces),

5) 03 (THREE) Packets of ESSEL WORLD (3 in 1) by Varshini Fireworks Industries (each packet containing 03 pieces),

PSI- Abhishek Theengh of Matigara Police Station, Siliguri Commissionerate do hereby lodged this written complaint against the above mentioned accused person namely Bharat Kumar to the effect that today on 03.11.2021 at 18.05 hrs received a secret information that one Dayanand Gupta has stored huge quantity of Fire-crackers at his shop at Khaprail Bazar area for selling the same in the open market for his wrongful gain without having any license or other valid documents in respect of the same, violating the provision of law which may endanger human life and likely to cause injury of human life. This refers to Matigara PS GDE No- 130 dated 03.11.2021. Accordingly, as per your kind order I along with PSI- Newton Biswas, ASI- Nitai Mandal, C1035 Santosh Rabidas, CV/155 Sukumar Das, CV/387 Sukumar Barman all of Matigara PS, SPC rushed to the spot to work out the information. On the way to Khaprail Bazar, I summoned two disinterested witnesses namely (1) Rohit Sharma, S/O-Lt. Promanand Sharma and (2) Rajesh Jain s/o Lt. Bashilal Jain, both of Khaprail Bazar, PO- New Chamta, PS- Matigara, Dist-Darjeeling, apprised them about the information in hand and on request they agreed to accompany us in the whole raid, search and seizure process if required.

On reaching at Khaprail Bazar, I contacted with my source and being guided and identified by the source apprehended one person with the above mentioned seized articles (Fire crackers) being stored in his shop styled as at Khaprail Bazar styled as "Dayanand Store". On interrogation he disclosed his identity as noted above.,

Further, on demand he failed to produce any valid documents / license in support of the possession of such quantity of Fire crackers recovered from his shop. There is a reason to believe that Dayanand Gupta has stored the said consignment of fire crackers for selling the same in the open market for his wrongful gain, which are combustible in nature and endanger to human life and property at his shop styled as "Dayanand Store" at Khaprail Bazar illegally and violating Govt. Orders,. Moreover, the above noted fire crackers were stored without any precautionary and safety measures and thus, violated the section 285/286 of Indian Penal Code. Accordingly, I seized the above noted fire crackers under proper seizure list duly signed by the witnesses and acknowledged by the accused person namely Dayanand Gupta. The whole process of seizure was made between 18.55hrs to 19.45hrs. Subsequently, I arrested the above noted accused person namely Dayanand Gupta observing all the formalities and informing the ground of his arrest.

Under the above fact and circumstance, I pray before you that a specific case may kindly be started against the accused person namely Dayanand Gupta (48), S/O- Lt. Ram Chandra Gupta of Khaprail Bazar, PO- New Chamta, PS- Matigara, Dist-Darjeeling under proper section of law and arrange for its investigation.
