SUB:- LODGING OF FIR

On dated 30-10-2021, NO.001100811 HC RABIN MONDAL along with 02 or's detailed for 2ND shift ACP duty in AOR of BOP Fulbari in between BFL no -10 to 19 and BP no.731/1-s to 732/5-S. NO.001100811 HC RABIN MONDAL was entrusted to perform duty from BFL pole no-13 to 16 ahead of IBB fence. Duty sentry noticed the suspicious movements of smugglers / miscreants (in alignment of BP No.732/4-S in between BFL no.13 to 14. Then he challenged the smugglers on the being challenged, smugglers took aggressive posture and trying to cross cattle through feasible gap (in 300 Mtr old fence which is not held on charge) forcefully from India to Bangladesh. Then NO.001100811 HC Rabin Mondal fired 01 No's of PAG CARTG (PAG Butt NO. 66 Body NO. 13 PAG 608862). Resulting which smugglers fled away from the spot taking advantage of darkness and thick vegetation ACP party in their respective sides leaving behind 01 cattle (worth Rs 18260/-). HC Rabin Mondal immediately informed the matter to Coy Commander and Coy Comder SH. Bharat Bhushan, AC reached the spot and carried out search operation & found that one cattle were recovered from inside the feasible gap (old fence) and seized as outgoing/unclaimed. EFC have been recovered and no injury noticed from either side.
