In producing herewith one (01) arrested accused persons namely Abhishek Minj (19) S/O Bipin Minj of Cetral Duars, Rangamati, P.O- Panabusty, P.S- Kalchini, Dist.- Alipurduar along with the following articles under proper seizure as per seizure list;

a) One Black colour Pittu bag styled as 'adldas' containing 32 (thirty two) bottles of "Lykarex" Cough Syrup (each bottle containing 100 ml) having Batch No. TBHU 0272, Mfg. Date: 02/2021. Exp. Date: 01/2023 which was - seized from exclusive and conscious possession of above noted Abhishek Minj and marked as "Exhibit-

b) One (01) bottle of "Lykarex" Cough Syrup (containing 100 ml) randomly taken from "Exhibit- A" for examination and marked as "Exhibit A-1".

I, PSI Newton Biswas S/O Nirmal Biswas of Matigara Police Station, Siliguri Police Commissionerate do hereby lodged this written complaint against the above noted accused person namely Abhishek Minj (19) S/O Bipin Minj of Cetral Duars, Rangamati, P.O- Panabusty, P.S- Kalchini, Dist.- Alipurduar to the effect that on 06.11.2021 at about 06.05 hrs. I received a specific source input that one person possessing huge quantity of 'Codeine Phosphate' based drugs was standing at Chang More, near City Centre under Matigara PS to sell the same to their designed customers. The matter was diarized in Matigara PS GDE No. 242, Dt. 06.11.2021 and subsequently, I informed the matter to the Officer-in-Charge, Matigara Police Station in written and being directed, myself along with PSI Abhishek Theengh, PSI Shekar Adhikary, ASI Tapan Das C/1035 Santosh Robidas all of Matigara PS, SPC along with investigation kit left for Chang More, Near City Centre under Matigara PS by Govt. vehicle to verify the veracity of the information. This refers to Matigara PS GDE No. 243, Dt. 06.11.2021 and M.C.C No- 560/2021 Date- 06.11.2021.

Under this circumstance any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender.

On way to Chang More, Near City Centre under Matigara PS I contacted two persons namely (1)Reeju Khan(39), S/O-Lt. Riyaj Khan and (2) Parimal Sarkar(40), S/O-Lt. Brojen Sakar both of Tumbajote, Beldangi, P.O+PS- Matigara, Dist- Darjeeling and make them aware of the information in hand and requested them to act as witness, if any search and seizure would be made necessary upon which, they agreed. Thereafter, we along with above noted independent witnesses arrived at Chang More near City Cenre under PS- Matigara at 06.35 hrs and subsequently, being pointed by my source, detained 01(one) person standing at Chang More near City Centre under Matigara P.S and he was carrying pittu bag under his exclusive and conscious possession. Thereafter, we disclosed our identity and the information in hand stated him that he as well as the bag under his possession will be searched for the purpose. And, I also gave him option in writing to be searched in presence of an Executive Magistrate or by any Gazetted Officer upon which he agreed to be searched in presence of any one of the above. I also offered the independent witnesses and the accused person to search our Police Party as per provisions but, they did not search the police party. Consequently, I informed the matter to O/C Matigara PS and as per his kind order, I informed to Shri Manabendu Sekhar Rakshit, Assistant Commissioner of Police, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate of SPC for the day, regarding the interception of the accused person suspected to be possessed 'Codeine Phosphate' based drugs illegally and requested him to come at Chang More near City Centre under Matigara PS to remain present and to supervise the search and seizure.

Accordingly at 07.35 hre Shri Manabendu Sekhar Rakehit, Accietant Commissioner of Police, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate of SPC arrived at the spot at Chang More neat City Centre under Matigara PS as Special Executive Magistrate, SPC and in presence of two independent witnesses I searched the detained person namely Abhishek Minj after following all formalities, keeping his decency and recovered the above noted articles from the exclusive and conscious possession of the accused person namely Abhishek Minj (19) S/O Bipin Minj of Cetral Duars, Rangamati, P.O- Panabusty, P.S- Kalchini, Dist. Alipurduar

It has been found from the bag under the exclusive and conscious possession of the above noted accused person namely Abhishek Minj containing 32 (thirty two) bottles of "Lykarex" Cough Syrup (each bottle containing 100 ml) having Batch No. TBHU 0272, Mfg. Date: 02/2021. Exp. Date: 01/2023 containing total 32 X 100 ml = 3200 ml i.e., equivalent to 3.2 Kg].

Further, on demand in presence of Shri Manabendu Sekhar Rakshit, Assistant Commissioner of Police, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate of SPC the detained person namely Abhishek Minj failed to produce any valid documents/papers or explanation for possessing of such huge quantity of 'Codeine Phosphate' based drugs beyond the prescribed limit.

Thereafter, I seized the recovered 32 (thirty two) bottles [containing 3200 ml i.e., equivalent to 3.2 Kg] of "Lykarex" Cough Syrup [including I (one) bottle of "Lykarex" Cough Syrup (containing 100 ml) which was taken randomly from the mother packet for examination] from the exclusive and conscious possession of above noted accused persons namely Abhishek Minj at the spot at Chang More near City Centre under PS- Matigara, Dist-Darjeeling under proper seizure list in presence of independent witnesses and Shri Manabendu Sekhar Rakshit, Assistant Commissioner of Police, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate, SPC obtaining his signature and being acknowledged by the accused person namely Abhishek Minj.

Subsequently, I labelled and sealed the seized articles at the spot at Chang More Near City Centre under PS- Matigara, Dist- Darjeeling in presence of Shri Manabendu Sekhar Rakshit, Assistant Commissioner of Police, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate, SPC and independent witnesses and the accused person namely Abhishek Minj. The whole process of seizure was made in between 07.45 hrs to 08.15 hrs.

Being further interrogated, the apprehend person namely Abhishek Minj admitted in presence of Shri Manabendu Sekhar Rakshit, Assistant Commissioner of Police, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate of SPC and independent witnesses that he has procured the 'Codeine Phosphate' based drugs clandestinely for the purpose of selling the same in high rate to his designed customer for his personal gain by illegal means. He also disclosed that he has been dealing in this business of procuring and selling of 'Codeine Phosphate' based drugs illegally for last few months for his wrongful gain.

From the above noted facts and seizure of incriminating articles it is quite evident that the accused person namely Abhishek Minj is involved in procuring and selling 'Codeine Phosphate' based drugs illegally contravening the norms of NDPS Act.

Then, I arrested the above noted accused person namely Abhishek Minj after observing all formalities and informing the ground of their arrest and issued necessary Memo of Arrest.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the accused person namely Abhishek Minj (19) S/O Bipin Minj of Cetral Duars, Rangamati, P.O-Panabusty, P.S- Kalchini, Dist.- Alipurduar and arrange for its investigation.
