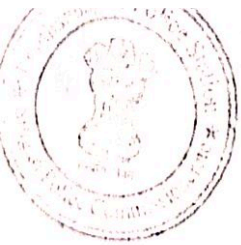

With due respect and humble submission, in producing herewith one accused namely Goutam Chakraborty(30)Lt.Sudev Chakraborty of Baghajatin Colony, 2/45,Ps Pradhan Nagar/Djg under arrest along with following articles under proper seizure ;

- i) 13(thirteen) bottle Himalayan Gold 60' UP country spirit each bottle 600 ML
- ii) 10(ten)bottles of Himalayan Gold 60up each bottle 300 ml

I SI. Haren Kumar Mohanta of Pradhannagar PS, SPC would like to lodge this written complainant against the above noted accused person to the effect that today on 20.10.21 when I along with SI.Binup Mahato,ASI.Debasish Das, CV/128 Ajay Kr Sahani,CV/223 Swapan Chettri was performing Special Raid duty vide PDN PS GDE NO .121 dt. 02.11.21. I received an information that one person namely Goutam Chakraborty(30)Lt.Sudev Chakraborty of Baghajatin Colony, 2/45,Ps Pradhan Nagar/Djg has storage huge quantity of illegal liquor in his hotel situated at Regulated market under Pradhannagar PS and selling the same in his shop without any authority or license. Accordingly, I share the information to you and as per your kind instruction myself along with force rush to the spot and hold raid in the hotel noted above and detained the above noted person and on being search his hotel recovered above noted articles , On demand he failed to produce any valid document in respect of recovered articles .On interrogation he admitted that he is selling the same illegally without obtaining valid license/document for his illegal gain. Accordingly, I seized & label the above noted articles in between 22:35 hrs to 23:15hrs and I arrested him.

Therefore, I request you to start a specific case under proper section of law against the arrested person namely Goutam Chakraborty(30)Lt.Sudev Chakraborty of Baghajatin Colony, 2/45,Ps Pradhan Nagar/Djg and arrange for its investigation.
