I, SI Haren Kumar Mahanta of Pradhannagar PS, SPC do hereby producing the arrested accused producing the arrested accused innagar PS Diet Docinette person namely Alok Biswas (21) s/o Ashit Biswas of Ganesh Ghosh Colony PO Champasari PS Pradhannagar PS Dist Darjeeling along with seized Fire crackers viz; (i) 17 Packets of Lanka Pataka Styed as cornation electric crackers each packet containing 28 pieces, (ii) 06 Packets of Lanka Pataka Styed as King cobra each packet containing 28 pieces.(iii) 04 Packets of Big ground chakkar each packet containing 25 pieces (iv)02 packets of Rocket crackers each packet containing 10 pieces (v)01 packets of Deluxe Chakka containing 10 pieces(vi)14 Packets of jugmug chocklet containing 10 pieces (vii) 03 packets of Didi Ma"s Flower pots each packet containing 10 pieces (viii) some loose chocklet crackers. In this regard I beg to complain that today i,e 03.10.21 at 20.05 hrs received a secret information over telephone that one Alok Biswas(21) owner of Grossery shop situated Ganesh ghosh colony under Pradhannagar PS have been storing and selling of such banned Fire-crackers without having any license or other valid documents violating the provision of law, which may endanger of human life, likely to cause injury and may cause loss of public property of the area, I informed the matter to Inspector-in-charge SPC & ACP, west, SPC. As per their kind orders I accompanied with PSI Sumit Sarkar ASI Raju Sarkar, , C 1446 Nirmal Roy C 1416 Dilip kr Barman rushed to the spot by govt. vehicle to work out the information. On arrival at Ganesh ghosh colony and contacted with source and as shown by source we cordoned the alleged shop.

Accordingly we conducted raid in the said shops of Alok Biswas. On searched I recovered above noted fire-crackers from the said shop. On being asked regarding storing and selling of banned Fire Crackers he could not produce any valid documents or licenses in support of the possession of such quantity of banned Fire Crackers recovered. It is pertinent to mention herein that the shop of above noted accused namely Alok Biswas is situated in the densely market area of Ganesh Ghosh colony and its adjacent areas are also densely populated area, the accused was carrying such illegal business of banned fire crackers without any safety measure and without any permission from appropriate authorities, if any accident took place due to negligent act of the accused person that may cause huge loss of life and property of that area. The Fire crackers were stored without any precautionary and safety measure, thereby, violating the Section 285/286 of IPC and Section 24 of WBFS Act. Accordingly, I seized the fire crackers under proper seizure list. And arrested the above noted accused persons U/S 41 Cr.P.C. And the seizure was made between 20:20 to 20:55 Hrs.

Under the above circumstances, I pray before your kind end to start a specific case against the arrested person named Alok Biswas (21) s/o Ashit Biswas of Ganesh Ghosh Colony PO Champasari PS Pradhannagar PS Dist Darjeeling and arrange for its investigation.
