In producing herewith 12 (Twelve) accused persons namely (1) Raju Roy (46) s/o Lt. Ranjit Roy of Ramajote Bhujipani PS Bagdogra Dist. Darjeeling (2) Swapan Barman (33) s/o Chatra Mohan Barman of Goursingh jote PS Khoribari Dist. Darjeeling (3) Madhav Roy (47) s/o Lt. Makhan Lal Roy of Rathkhola PS Naxalbari Dist. Darjeeling (4) Bunu Debnath (28) s/o Naba Debnath of Panitanki PS Khoribari Dist. Darjeeling (5) Arjun Roy (45) s/o Lt. Dhaneswar Roy of Rupsinghjote, Gossainpur PS Bagdogra Dist. - (4) 2 (two) Surya tube light.
- (5) 03 Packets of WILLS NEVY CUT Cigarette.

I, SI Dipanjan Bhadra of Bagdogra PS, Siliguri Police Commissionerate do hereby lodged this complaint to the effect that on 02.11.21 at 20.05 hrs received source of information that a gambling was going on inside of a room in the house of one Raju Roy at Ramajote Bhujipani. Accordingly informed the matter to O.C., Bagdogra PS and as per his kind direction diarized the matter vide Bagdogra PS G.D.E. No. 1646 dtd. 02.11.21 and as per direction of O.C. PS myself along with force of Van- K-35 and ASI Dharendra Nath Mandal, Const.410 Montosh Singh, CV-386 Kishor Halder, CV-379 Janak Singh, CV- 375 Jogesh Barman, VP-02 Pradip Roy all of Bagdogra PS left for the spot to verify the veracity of information vide Bagdogra PS G.D.E.No.1647 dt- 02.11.21. On reaching the spot found that the above noted accused persons and others are playing gambling in a room of the house of Raju Roy with the help of Playing Cards to each other by huge quantity of cash to wrongful gain and wrongful loss and on seeing the police party, they try to flee away from the spot, but on hot chased I alongwith other officers and force apprehended the above noted accused persons. On being searched the spot the above noted articles are found lying there and Cash Rs.2,30,260=00 recovered as board money from the gambling board. Accordingly I seized all the above noted articles in presence of witnesses under proper seizure list with a view to take legal action as they violated the prohibition U/S- 3/4 of W.B.G. & P.C Act.

In this circumstances it is clear that the above noted accused persons violated sec - 3 / 4 of W.B G & P.C Act-1957. Accordingly I arrested them as they are violating the above mentioned section of the Acts. The seizure and arrest have been made between 20-25 hrs to 21-55 hrs.

Hence, I request to you kindly start a specific case U/S- 3 / 4 of W.B G & P.C Act-1957 against the above mentioned 12 (Twelve) accused persons and for onwards investigation.
