With due respect, I am producing herewith one arrested person namely Ranjit Das (42 yrs), s/o – Hiralala Das of Dudhiya, PO- Milanpally, PS- NJP, Dist: Jalpaiguri along with following seized fireworks /fire crackers under proper seizure list viz:

- 1. One (01) box Pop containing 30 packets inside the box.
- 2. Twelve (12) packets of chilli crackers styled as "KING COBRA ELECTRIC CRACKERS" each packet containing 28 Pcs.
- 3. Ten (10) packets of Dulkar Electric sparklers each packet containing 10 box manufactured by Mohan Industries.

I ASI Sanjoy Saha of Milanpally OP under NJP P.S under Siliguri Police Commissionerate do here by lodged the complaint to the effect that on today i.e 30.10.2021 at evening while performing special raid duty against the illegal fire crackers as per order by O/C Milanpally OP vide Milanpally OP GDE no-725, Dated: 30.10.2021 myself along with C/1052 Dipak Das, C/694 Sushil Saibo, VP/12 Dasarath Roy conducted raid against selling, storing of illegal fire crackers in the shop style as Sreema Store inside the Takimari Bazar P.S-NJP, Dist: Jalpaiguri as there was secret source information that Ranjit Das of Sreema Store of Takimari bazaar had been storing and selling the fire crackers of beyond permissible sound limit illegally to the customers. During raid apprehended one person who on being asked identified himself as noted above and found him possessing above noted seized fire crackers kept concealed in his shop.

On being asked the said Ranjit Das admitted his guilt of purchasing, storing and selling of fire crackers at his shop without any licence or violated the order of Hon'ble High Court. He also could not produce any documents in respect of huge amount of those fire crackers. The fire crackers was kept and stored without any precautionary and safety, measure at his shop. The said stored fire crackers are combustible in nature and endanger to human life and property. So, I seized the fire crackers under proper seizure list duly signed by the witnesses and the said person. Accordingly, I arrested the above noted person u/s 41 Cr.P.C and acknowledge to the accused person. The seizure was made in between 19.25 hrs to 19:45 hrs.

Hence, I pray before you that a specific case may kindly be started against the person namely Ranjit Das (42 yrs), s/o – Hiralala Das of Dudhiya, PO- Milanpally, PS- NJP, Dist: Jalpaiguri under proper section of law and arrange for its investigation.
