
1. 1 (One) bottles of Himalayan Gold Country Spirit containing 600 ML in each bottle.
2. 12 (Twelve) bottles of Himalayan Gold Country Spirit containing 300 ML in each bottle.
3. 06 (Six) bottles of HAYWARDS - 5000 Super strong Beer containing 650 ML in each bottle.
4. 03 (Three) bottles KINGFISHER Strong Premium Beer containing 650 ML in each bottle

I, SI Samik Paul presently attached with NJP PS under your kind control beg to state that today i.e. on 31.10.21 at 18.15 hrs I received a secret source information that one person namely Ranjit Barman S/O Keshab Barman of near Yuba Bharati Club, Central Colony, PS- NJP, Dist. Jalpaiguri is selling I/D liquor illegally at his residence for his illegal gain. Accordingly, I dialed the fact in the General diary vide NJP PS GD No 1363 dated 31.10.21 and informed the fact to you. As per your kind direction and instruction myself along with HG/794 Ranjit Roy and CV/306 Biswajit Roy all of NJP PS, SPC left for the house Ranjit Barman of near Yuba Bharati Club, Central Colony, PS- NJP, Dist. Jalpaiguri to work out the information in hand. At about 18.30 hrs we arrived at the house of Ranjit Barman and being shown and identified by the source I held him at the house Ranjit Barman S/O Keshab Barman of near Yuba Bharati Club, Central Colony, PS- NJP, Dist. Jalpaiguri and managed to apprehended him. During interrogation he disclosed his identity as noted above and also disclosed that he is selling I/D liquor at his residence since long for his illegal gain. On search the above noted I/D liquor recovered from his possession. On demand he failed to produce any documents/licence in respect of store/side the I/D liquor at his residence. Accordingly, I seized the above noted I/D liquor from his possession under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search, seizure & arrest was made in between 18.55 hrs to 19.45 hrs on 31.10.21.

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely Ranjit Barman (20 yrs) S/O Keshab Barman of near Yuba Bharati Club, Central Colony, PS- NJP, Dist. Jalpaiguri and arrange for its investigation.
