Darjeeling selling Contrband Fireworks at Thanga More, Baribhasa for his illegain gain. Accordingly, I diarised the fact in General diary vide NJP PS GDE No 126 dated 03.11.2021 at 2205 hrs and informed the fact to you as well as Asstt Commissioner of Police, East -II, SPC. As per kind order and direction of my superior Officers myself along with others available officers and force namely NVF/0065 Prakash Roy, NVF/0089 Shyamal Roy and NVF/0129 Majnu Md left for Thang Banga More, Baribhasa to work out the information in hand.
