Sir,

I, SI Dilip Kr Paul of Pradhannagar PS, SPC do hereby producing one absconding accused person namely Sanjay Das S/o late Kamal Das of Colipara PS- Pradhannagar Dist-Darjeeling along with seized Fire crackers viz; i) 12 packets of Jugmug chocolate junior pataka each packet contains 12 pcs. total 144 Pcs. ii) 26 packets of Lanka potaka styled as Cornation electric Cackers each packets contains 28 Pcs. =Total 728 Pcs iii) 19 packets of Lanka potaka each packet contain 28 Pcs. total= 532 Pcs. iv) 10 packets of Delux Chakkar each packet contains 10 pcs. 100 Pcs. In this regard I beg to complain that today i,e 03.10.21 at 20.35 hrs received a secret information over telephone that one Sanjay Das owner of shop situated at Colipara under Pradhannagar PS have been storing and selling of such banned Fire-crackers without having any license or other valid documents violating the provision of law, which may endanger of human life, likely to cause injury and may cause loss of public property of the area, I informed the matter to Inspector-in-charge SPC & ACP, west, SPC. As per their kind orders I accompanied with ASI Prabal Sarkar ASI Suresh Kami, C 1119 Tanmoy Roy C 1169 Presenjit Barman rushed to the spot by govt. vehicle to work out the information. On arrival at Colipara and contacted with source and as shown by source we cordoned the alleged shop.

Accordingly we conducted raid in the said shops of Sanjay Das. On being seen the police party the accused person fled away from his shop. On searched I recovered above noted firecrackers from the said shop with the presence of independent witnesses namely 1)Uttam Chakrabarty s/o Nitul Chakbarty of Panchanai Colony PS Pradhamnnagar Dist Darjeeling 2)Pulak Chatterjee s/o Lt L.K chatterjee Of Nivedita Road PS Pradhannagar Dist Darjeling. It is pertinent to mention herein that the shop of above noted accused namely Sanjay Das is situated in the densely market area of Colipara and its adjacent areas are also densely populated area, the accused was carrying such illegal business of banned fire crackers without any safety measure and without any permission from appropriate authorities, if any accident took place due to negligent act of the accused person that may cause huge loss of life and property of that area. The Fire crackers were stored without any precautionary and safety measure, thereby, violating the Section 285/286 of IPC and Section 24 of WBFS Act. Accordingly, I seized the fire crackers under proper seizure list. Seizure was made between 20:50 to 21:50 Hrs.

Under the above circumstances, I pray before your kind end to start a specific case against the absconding accused person named Sanjay Das S/o late Kamal Das of Colipara PS-Pradhannagar Dist-Darjeeling and arrange for its investigation.
