Respected Sir,

With due respect I, Sri Ashis Halder, Son of Late Nakulendra Mohan Halder, Resident of Panchkolguri, P.O. - Sahudangi Hat, P.S.-New Jalpaiguri, District- Jalpaiguri, West Bengal, would like to inform you that on 08/11/2021 at about 02:00 P.M. suddenly Subhojit Acharjee, Subhojyoti Acharjee, Jagadish Acharjee, Sanjay Routh, his wife, his brothers, his brother's wife, his sister -in-law and others, all are Resident of Panchkolguri, P.O. - Sahudangi Hat, P.S.-New Jalpaiguri, District-Jalpaiguri, West Bengal, started quarrel with me to obstruct my gate for closing my back side entrance. When I tried to stop them, they started to assault me with fist, blow etc. in order to kill me and as a result I suffered several injuries on my chest, abdomen and head and thereafter my wife namely Alpana Halder came out from our house and tried to protect me but at the same time Subhojit Acharjee, Subhojyoti Acharjee, Jagadish Acharjee, Sanjay Routh, his brothers and others also started to assault her and with force tore off her sharee and inner clothing and they could make her naked and even tried to kill her. My daughter namely Ankita Halder is an Advocate. They told us no advocates can do anything to them and told all advocates are purchasable and they are like a black crow. They also told that no one can do anything to them. They use filthy languages addressing to me and my other family members by raising our caste to the following effects :- ".....Sala nichu Jaat ar suyor-kukur ar dal, Sala toder ato sahos j
