**Subject :-** Kindly lodge a FIR against seven Brokers / Hooligan who were snatched my personal mobile phone and submitted it to the MVI or ARTO official in Parivahan Nagar, Matigara at around 2:30 p.m. to 3:45 p.m. yesterday.

Respected Sir / Madam,-

With due respect I ( Samindra Kumar Das ) S/o Smt. Santa Das would like to inform and request to you kindly lodge a FIR against Seven Brokers / Hooligan who snatched my personal mobile phone and submit it to MVI or ARTO official yesterday at around 2:30 p.m. to 3:30 p.m. at Matigara Parivahan Nagar where MVI or ARTO take Driving Skill Test .

The matter is that I went to the spot to collect and gather more evidence ( like Audio Video and Photos ) of Brokers / Hooligan who are collecting bribe to pass out the applicants via MVI or ARTO of Skill Test organized by the RTO Siliguri through my mobile phone. While I was taking evidence ( like Audio Videos and Photos), the brokers came to know about it and forcibly snatched my mobile phone and deposited it to the MVI or RTO official . The Brokers insult and intimidate me with vulgar language. If the MVI /RTO officials are not involved in corruption with the Broker or Hooligan, then how did the official accept my mobile when the Brokers or Hooligan give it to him. If I doing anything wrong then why don't they called the police ? This proves that Brokers or Hooligan and RTO officials are equally involved in corruption . If the RTO official was not involve then why don't he submit the mobile phone to the police station .

At that time I was only one and helpless, if I said anything against them maybe they would kill me. So I left without saying anything and went to the Siliguri Police Commissioner's Office to lodge a complaint. I came to your office on 8/11/2021 at 8:30 pm to lodge a FIR about the corruption of RTO officials but your on duty 2<sup>nd</sup> officer did not accept it. And he suggested me verbally that " the RTO officials did not ask me to provide them bribe directly. That is why I should file an FIR against the broker or Hooligan in spite of RTO Official" . So I complained to the Siliguri Police Commissioner yesterday. I have a lot of valuable information in this Mobile. They can ruin my Mobile phone . My mobile phone ( Vivo Y12 model ) exists two Mobile Numbers ( 1. 9434982898 and 2. 8250036691, IMEI 1= 867263044277172 AND IMEI 2= 867263044277164, SN= A904SL306C00 ) and One Micro SD card .

Therefore it is my humbly request to you that please lodge a FIR and take legal action against Seven Broker or Hooligan and MVI or ARTO or RTO officials who were involve into this. And also get back my mobile phone to me as soon as possible. You can trace my mobile phone through your communication system .
