(1) 15 (Fifteen) Bottle Of Himalayan Gold 60 up country sprit each containing 600 ML

I, SI Prokash Saha Saha of Bhaktinagar PS, SPC lodged a written complainant against the above noted person to the effect that today i.e. on 13/11/21 at 15.40 hrs received a source information that one person namely Tinku Majumder has gathered huge amount of liquor illegally in his house for selling the same in the customer for his wrongful gain. Accordingly diarized the fact in GD vide Bhaktinagar PS GDE No- 693 Dated 13.112021 and shared the information with I/C Bhaktinagar PS and as per his kind instruction this refers to Bhaktinagar P.S. GDE No-693 Dated 13 11.2021 at 15.50 hrs I along with CVF 614 Sumit Kumar Roy and CVF/ 619 Dharmendra Roy left for Bhanu nagar in the house of Tinku Majumder and identified by the source our police party cordoned the house of Tinku Majumder and conducted raid and recovered the above noted articles from his house from the exclusive possession of the above noted accused person namely Tinku Majumder. On demand he could not produce any valid license/documents in support of said liquor. He became nervous and admitted his guilt before us and stated that he sells the same to his design customers in his house for his wrongful gain. In presence of witnesses Namely CVF 614 Sumit Kumar Roy and CVF/ 619 Dharmendra Roy I seized the above noted articles from the possession of above noted accused person after preparing proper seizure list and took signature of the accused person. The seizure was made between 16 15 hrs to 16.45 hrs as he violated the rules and norms of Bengal Excise Act as such. I arrested the said accused person u/s 41 Cr.P.C. and issued Memo of arrest appraising the ground of arrest.

I therefore request you a specific case may kindly be started against the accused person namely Tinku Majumder S/o lt Dulal Majumder of Bhanunagar Chowrangi more Ward No 43 Ps Bhaktinagar Dist Jalpaiguri under proper section of law and arrange for its investigation.
