In producing herewith two arrested accused persons namely (1) Khokan Sutradhar-37yrs s/o Ganesh Sutradhar of Bhanunagar near Agradut Sangha ward No-43, PS Bhaktinagar Dist Jalpaiguri and (2) Prem Biswakarma -27yrs s/o Sambhu Biswakarma of Sastrinagar Tiranga More, PS Bhaktinagar Dist Jalpaiguri under proper memo of arrest along with seized articles viz;

55 (Fifty Five) strips of Winspasmo Forte capsules each strips containing 10 piece total (55X10) =550 pieces marked as Exhibit-A composition with Tramadol hydrochloride-1P 50mg Acetaminophen 1P 325mg & Dicyclomine Hydrochloride 1P 10mg (among which two strips containing 2X10=20 pcs taken as sample) marked as Exhibit-A1 from the possession of arrested Accused persons which was kept in a paper packet.

I beg to report that on 13.11.21 at 14.55yrs, received source information that since few days the above noted persons were selling illegally procured spurious drugs from Sevoke road area under Bhaktinagar PS to local peoples and others without valid license or documents and may be apprehended with such drugs, if responded immediately. Accordingly, the matter was diarised in General Dairy vide Bhaktinagar PS GDE no- 690 dated 13.11.21 and after informing your end and without making further delay I along with SI Prakash Saha, C/374 Debraj Biswas, CVF/935 Bipallb Roy and CVF/619 Dharmendra Roy all of Bhaktinagar PS rushed to the spot at PO vide GDE no-691 dated 13.11.21. Also, informed Drug controller Jalpaiguri, over telephone to be present at the spot but he failed to appear on the spot.

On the way, sought the service of the two persons namely (1) Bapi Paul-35yrs s/o Badal Paul of New Palpara, Near Mahamaya Club, ward no-39 PS Bhaktinagar, Dist Jalpaiguri & (2) Mithun Roy-32yrs s/o Prabin Roy of Sri Sati Saw Mill, ward no-42, PS Bhaktinagar Dist Jalpaiguri to stand as a witnesses during the search and seizure and arrest, if any. At 15.25 hrs, reached at the spot and contacted with the source and keeping the Govt vehicle at a distance started on foot. As pointed by the source, we cordoned the area in presence of the witnesses and managed to apprehend two male persons noted above who were standing at Sevoke road near Sky View Hotel and disclosed our identity as police personnel. On being asked, the persons disclosed their identity, as noted above. Then, following all formalities, we conducted search of those persons and noticed

the above noted drugs which were kept in their possession of accused persons could be recovered.

On interrogation, the apprehended persons in respect of such possession, they stated different statements at different interval of times, which had given rise to suspicion that they have procured the same illegally for their clandestine disposal. Further, on demand, they failed to produce any valid papers or documents in support of such possession of illegal capsules. Further, they admitted to have procured the said recovered drugs illegally for consuming them and peddling them to the drug addicts without any prescription.

Accordingly, after observing all formalities, I seized and labelled all the recovered drugs under proper seizure list and label duly signed by the witnesses and acknowledged by the accused persons and also, arrested the apprehended above noted accused persons u/s 41 Crpc. All the formalities of seizure and arrest took place in between 15.55 hrs to 16.50 hrs.

Under the above circumstances, I pray before your kind end to start a case against the above arrested accused persons namely (I) Khokan Sutradhar-37yrs s/o Ganesh Sutradhar of Bhanunagar near Agradut Sangha ward No-43, PS shaktinagar Dist Jalpaiguri and (2) Prem Biswakarma -27yrs s/o Sambhu Biswakarma of Sastrinagar Tiranga More, PS Bhaktinagar Dist Jalpaiguri under proper sections of law and arrange for its proper investigation.
