While conducting a market survey under your jurisdiction it has come to light that various persons in this area are involve in the manufacturing / dealing and selling of Spurious / Counterfeit automotive parts & packing material purportedly manufactured by M/s Kirloskar Proprietary Limited. They are selling spurious products in our company name, not made by us thereby copying the art work of M/s. Kirloskar Proprietary Limited and also violating the sections of Copy Right Act.

Use of spurious motors parts is most likely to cause serious damage to vehicles used by public in general and there is every possibility that the engine of the vehicles will get damaged and it may lead to serious accidents. Also damage the credit of company.

Therefore, I request your kind honour to investigate the above matter and take appropriate action against the owner of (i) National Auto Agency (ii) National Auto Suppliers both of Sevoke Road under PS Siliguri and others persons involved in the above illegal sale of spurious / counterfeit Kirloskar parts and do the needful.
