## Sub :- FIR

As reported by Pritam Paul, Biiswajit Biswas, MD. Anarul, Ruma Podder, Sampa Majumder and Harimonty Das Gorai (Indoor Stadium vaccination team staffs) one person namely "Arjun" alias Madhab(as stated by himself to our staff and other Indoor Stadium Staff) is taking advantage by falsifying his identity, saying that he is a BOROUGH Staff and works under Duare Sarkar Scheme under BOROUGH - III.

He introduced himself to other indoor stadium staff and other nearby shops as health staff and have taken advantage like free meal etc. and did not pay the bills. Until now six beneficiaries reported over phone to the Indoor Stadium staff that they have given money to take vaccine in Indoor Stadium to the same person, however no Cowin entry is made of the same.

His phone number was collected today from beneficiaries i.e. **8016274891** and called citing other reasons, he came with a scooty (Maestro edge) bearing registration number **WB 74 AT 5586** (which is found to be registered in the name of Rani Mondal Sarkar from mParibahan App) and when he was confronted and police was informed over phone he escaped leaving the scooty in Rabindra Mancha premises.

Therefore, you are requested to treat the matter as FIR and take necessary legal action against the wrong doer.
