In producing herewith five (05) arrested accused persons namely (1) Md. Anupam @ Md. Siraj @Khan (19/M), S/O- late Md. Rafiq of Vivekananda Road, Khalpara, near red light area, ward No.07 PS- Siliguri, Dist- Darjeeling, (2) Md. Saddam (19/M), S/O- Late Md. Alauddin of Koyla Depot, Ward No.07, PS- Siliguri, Dist- Darjeeling, (3) Ranjit Singh (30/M), S/O- Lt. Ram Singh of Asraf nagar infront of Maszid, ward No-40, PS- Bhaktinagar, Dist- Jalpaiguri, (4) Rajib Dasgupta (50/M), S/O- Late Tarak Dasgupta of Gurung Busty, near Gumpha, PS- Pradhannagar, Dist- Darjeeling and (5) Mahabir Sahani (20/M), S/O- Parameswar Sahani of Velkipara, Furfuri Nagar PS- New Jalpaiguri, Dist- Japlaiguri arrested u/s- 41 Cr.P.C along with following seized articles viz:

- (1) One metal made 'Bhojali' measuring 48 cm (approx) including wooden handle from the possession of Md. Anupam @ Md. Siraj @Khan which was kept concealed on his back side,
- (2) One iron claw bar measuring 58 cm (approx) from the possession of Md. Saddam which was kept concealed on his back side,
- (3) One metal made claw hammer measuring 24 cm (approx) and one iron bar having sharp end measuring 11 cm (approx) from the possession of Ranjit Singh which were kept concealed on his waist and right side of pocket respectively,
- (4) One metal made hammer measuring 11 cm (approx) having bamboo handle measuring 35 cm (approx) and some quantity of red chilli powder in a black coloured plastic from the possession of Rajib Dasgupta which were kept in his back side and right side of pocket respectively.
- (5) One metal made Axe measuring 16 cm (approx) having wooden handle measuring 62 cm (approx) from the possession of Mahabir Sahani which was kept on his right hand.
- I, SI- Upendra Nath Roy of Khalpara TOP-II under Siliguri PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted accused persons and others to the effect that today on 27.11.21 at 01.05 hrs received a sources information that 10/11 youths have assembled near Mahananda river bed near Shantoshi Nagar Ghat, Siliguri with a view to commit docoity in a house at that area. The fact was diarized in GD vide Khalpara TOP GDE No- 719 dated 27.11.21. Subsequently after sharing the information with my superiors and as per their direction, myself along with SI Md. Shajahan Ali, ASI- Md. Aminul Islam, ASI- Niranjan Sarkar, ASI- Sanjoy Hasda, C/1183 Nikhil Saha, C/1072 Anand Thakuri, C/390 Sujit Paul, C/1048 Gopal Roy C/239 Badal Barman, CV/916 Amaresh Sah, CV/980 Ranjan Ojha left for the place to work out the information. We reached at near Mahananda river bed near Shantosi Nagar Ghat, Siliguri at 01.25 hrs and subsequently cordoned off the suspected persons as shown by the source with a strong reason to believe that they were preparing to commit some cognizable offence and was about to move from that place seeing police personnel.

They tried to flee away but on hot chase we managed to apprehend above noted five (05) accused persons along with seized articles as mentioned above. However the other persons managed to flee away from the spot taking the advantage of darkness. On interrogation the accused person admitted that they had assembled there to commit dacoity in a house at that area.

I thereafter, seized the above noted weapons under proper seizure list duly signed by the witnesses and acknowledged by the accused person. The whole seizure was made in between 01.55 hrs to 02.35 hrs. Thereafter, I arrested the above noted accused persons u/s 41 Cr.P.C under proper memo of arrests duly signed by the accused persons and also supplied the copy of the memo of arrest to them.

I accordingly brought the arrested accused persons along with seized articles at Siliguri Police Station for further investigation. During the course of interrogation it could be revealed from the arrested accused persons that they along with some others were assembled there and planned for committing dacoity in a house near Shantoshi Nagar Ghat, Siliguri.

Hence, a specific case may kindly be started under proper section of Law against the above noted accused persons viz. (1) Md. Anupam @ Md. Siraj @Khan (19/M), S/O- late Md. Rafiq of Vivekananda Road, Khalpara, near red light area, ward No.07 PS- Siliguri, Dist- Darjeeling, (2) Md. Saddam (19/M), S/O- Late Md. Alauddin of Koyla Depot, Ward No.07, PS- Siliguri, Dist- Darjeeling, (3) Ranjit Singh (30/M), S/O- Lt. Ram Singh of Asraf nagar infront of Maszid, ward No-40, PS-Bhaktinagar, Dist- Jalpaiguri, (4) Rajib Dasgupta (50/M), S/O- Late Tarak Dasgupta of Gurung Busty, near Gumpha, PS- Pradhannagar, Dist- Darjeeling and (5) Mahabir Sahani (20/M), S/O- Parameswar Sahani of Velkipara, Furfuri Nagar PS- New Jalpaiguri, Dist- Japlaiguri and others and arrange for its investigation.
