Dear Sir.

This is to bring to your kind notice the following facts:-

- 1. My father, Pawan Kumar Agarwal, died on 4th August, 2011 he used to run a business of Shoes. In the year 2013, one Sitaram Bhutra, s/o Late Hiralal Bhutra, resident of Pradhan Nagar (Near Heritage Hotel, P.O. & P.S. Pradhan Nagar, Siliguri), offered to help me run my father's shoe business and on 03.05.13, he became my partner. In 2014, he invested a sum of Rs. 5, 00,000/- in the aforesaid business. In 2015, he gave me a loan of Rs 10. 00,000/- and I used to pay the aforesaid Sitaram Bhutra a sum of Rs. 15,000/- per month as interest on the aforesaid amount. And as he was a widower he used to have his meals (3 times a day) in our house.
- 2. In October 2018, I expressed my desire to break the partnership agreement with Sitaram Bhutra. At this, Mr. Sitaram Bhutra asked for return of his money otherwise he would not let me break the arrangement that I had with him. It is pertinent to mention that he had kept the original Sale Deed of our residential flat as security for the loan and he refused to return the aforesaid Sale Deed, the accounts books of business, unless I return his money.
- Ultimately, at the intervention of friends and well-wishers the aforesaid Sitaram Bhutra on 18th January, 2019 agreed to return me my business account book, Sale Deed of my flat and the loan agreement on payment of Rs. 21,00,000/-. Thereafter, I gave Sitaram

- 4. Though I gave him the aforesaid cheque, Sitaram Bhutra failed to return me the aforesaid documents (except my sale deed) despite repeated reminders within the next five days i.e. within 23.01.19. As I had to go to Ahmedabad on 26.01.19, I stopped payment of the aforesaid cheque on 24.01.19.
- 5. In the meantime, Sitaram Bhutra deposited the aforementioned cheque which was returned dishonoured. After I returned from Ahmedabad, I requested Mr. Sitaram Bhutra to return my original documents, but he avoided returning the same to me on the ground that they had been misplaced. Thereafter, Sitaram Bhutra got a legal notice issued and also obstructed me from opening my shop. At the end of February, 2019 Mr. Bhutra lodged a General Diary against me in the Panitanki Out Post (of Siliguri Police). Thereafter, when I explained the situation to the police, they told Sitaram Bhutra to return my documents, which he refused.
- 6. In the last week of March, 2019. Sitaram Bhutra sent 4 to 5 goondas to my shop and threatened me with dire consequences. Coming under pressure of those goondas, on 11th April, 2019, I transferred Rs. 13, 34,000/- (by NEFT) in Sitaram Bhutra's account of Allahabad Bank at Bidhan Market. On the same day, I also paid a sum of Rs. 7, 66,000/- in cash, as per his direction as this amount had not been shown in his Income Tax File. On the said date, he returned me the accounts books of my business and the loan agreement. However, he failed to return me the original cheque bearing no. 342866, dated 19.01.2019, of State Bank of India, Siliguri Branch, on the ground that the said cheque was with his lawyer.
- 7. Inspite of repeated follow ups and requests Sitaram Bhutra did not return me the aforesaid cheque till this date and has misused the cheque for filing a false case against me for dishonour of cheque in the court of the Ld. A.C.J.M. Siliguri, being C.R. Case No. 217 of 2019, now pending in the court of the Ld. Judicial Magistrate, 4th Court, Siliguri. Sitaram Bhutra has thus dishonestly induced me to deliver the aforesaid sum of Rs. 21, 00,000/- to him and has thus cheated me.

 Therefore, I request you to take necessary action as per law, against the above mentioned Sitaram Bhutra.
