Anii Sarkar C/O Santoshi Sweets of Motajote, Patharghata Road PS- Matigara, Dist-Darjeeling of Sweet Shop Styled as "Santoshi Sweets" situated at Motajote, Patharghata Road PS- Matigara, Dist-Darjeeling. Who was illegally procured the domestic Gas cylinder at his Sweet Shop styled as "Santoshi Sweets" for commercial purpose without any valid documents or license to the effect that today i.e. 03.12.21 at about 13:15 hrs received information from reliable source that one Nitya Nanda Sarkar (48yrs) S/O Lt. Anil Sarkar C/O Santoshi Sweets of Motajote, Patharghata Road PS- Matigara, Dist- Darjeeling is using the domestic Gas cylinder at his Sweet Shop styled as "Santoshi Sweets" for commercial purpose use for his wrongful gain.

Accordingly the matter informed to ACP EB SPC and as per his direction I, along with, ASI Prashanta Bardhan ,ASI Ashoke Biswas, C/424 Manik Roy , and CV/539 Kousik Mondal all of EB SPC with investigation kit left for Matigara PS vide EB SPC M.C.C No 155/21 Dt.03.12.2021. The matters informed to Matigara PS vide GDE No. 119/21 Dt.03.12.2021 and accompanied with Van K-33 officer ASI Mirja Hossain, C/765 P. Roy, C/809 M.T Sherpa all of Matigara PS vide Matigara PS MCC No 1289 /21 Dt.03,12.21 had been to Motajote, Patharghata Road PS- Matigara, Dist- Darjeeling, to work out the information and brief them about the information in hand and requested them to accompany with us during search and seizure. As per source identification we reached at "Santoshi Sweets" situated at Motajote, Patharghata Road PS- Matigara, Dist- Darjeeling and entered into Sweet Shop styled as "Santoshi Sweets" at mentioned address and found worker of Sweet shop by using the domestic Indane Gas, HP Gas cylinder without any valid documents for commercial use, on demand they failed to produce any valid documents in support of using the Indane Gas and HP Domestic Gas cylinders for commercial purpose. Further local enquiry it is revealed that the above noted accused person was using the domestic Indane Gas and HP Gas cylinder for preparing sweet items at his Sweet Shop as a commercial use for his wrongful gain without any valid document. I also managed independent witness namely (1) Rabi Biswakarma (26yrs) S/O Lt. Saran Biswakarma of Motajote , Patharghatta Road, Ps- Matigara, Dist- Darjeeling (2) C/424 Manik Roy of Enforcement

The owner of the Restaurant namely Nitya Nanda Sarkar used the domestic Indane gas cylinder abundantly for commercial purpose. Subsequently I seized the above noted articles in presence of witnesses after preparing proper seizure list and label .The seizure was made in between 14:45hrs to 15:15 hrs in presence of

Hence, I pray before you a specific case may kindly be started under proper section of law against the accused person Nitya Nanda Sarkar (48yrs) S/O Lt. Anil Sarkar C/O Santoshi Sweets of Motajote, Patharghata Road PS- Matigara, Dist- Darjeeling owner of Sweet Shop Styled as "Santoshi Sweets" situated at Motajote. Patharghata Road, PS- Matigara, Dist- Darjeeling and arrange for its investigation.
