

Sir,

I, PSI Newton Biswas of Matigara Police Station, Siliguri Police Commissionerate, do hereby lodge this written complaint, on producing one accused person namely Anand Panna (35) S/O Agnu Panna of Shibmandir, Indirapally, P.O- Kadamtala, PS- Matigara, Dist-Darjeeling under arrest along with following seized articles viz; (I) 13 (thirteen) Bottles of Himalayan Gold Country Spirit each bottle containing 600ml (total 600ml X 13=7.8 Ltrs.) and marked as "Exhibit-A" (II) 01(one) bottle of Himalayan Gold Country Spirit containing 600ml. taken out as sample from "Exhibit-A" for examination and marked as "Exhibit-A-1" under seizure list (which is enclosed herewith) to the effect that on 04.12,2021 at 18.15 hrs received a secret source information that one person namely Anand Panna (35) S/O Agnu Panna of Shibmandir, Indirapally, P.O- Kadamtala, PS- Matigara, Dist-Darjeeling has stored huge quantity of country spirit at his at his house without any valid license. Diarized the matter vide Matigara PS GDE No.178 Dt.- 04.12.2021 accordingly I informed the matter to O/C Matigara PS, and as per kind direction of O/C PS myself along with ASI Nitai Mondal, Const- 1035 Santosh Rabi Das, Const- 1008 Kanak Roy, left for Shibmandir Indirapally area to verify the veracity of the source information. On reaching at the spot at 18.35 hrs it was found that huge quantity of Country Spirit stored in the house of Anand Panna who has also been selling the same to the common buyers. On being seen the police party the common customers fled away from the backside of the house. But we apprehend the above noted person Anand Panna. There after I called two independent witnesses of that locality namely i) Gobinda Das (43) S/O Lt. Nagendra Nath Das of Sarat Nagar, Shibmandir, P.O- New Rangia, P.S- Matigara, Dist.- Darjeeling and ii) Rana Adhikari (35) S/O Lt. Ramen Adhikari of Shibmandir, Jhorua More, P.O. Kadamtala, PS- Matigara, Dist-Darjeeling and in the very presence of those witnesses I search the house and seized the above noted country spirit after preparing proper seizure List duly signed by the two independent witnesses and apprehend the person namely Anand Panna. On being asked the said person failed to produce any document for selling and storing liquor at the house. It's a violation under Bengal Excise Act. This seizure was made on 04/12/2021 in between 19:15 hrs to 19.35 hrs. Label was also prepared against total seized articles. I then arrested the accused Person namely Anand Panna (35) S/O Agnu Panna of Shibmandir, Indirapally, P.O. Kadamtala, PS- Matigara, Dist-Darjeeling after preparing memo of arrest and intimating the ground of arrest. On being asked by police he stated that he running this illegal business of liquor at the said house and selling the same to the common customers since last few months without any license or permission of appropriate authority.

Hence I request you to start a case under proper section of Bengal Excise Act- 1909 against the arrested Anand Panna (35) S/O Agnu Panna of Shibmandir, Indirapally, P.O. Kadamtala, PS- Matigara, Dist-Darjeeling and arrange for its investigation.
